

C-PAC elections scheduled for Upper Nehalem, Mist-Birkenfeld

Columbia County will hold Citizen Planning Advisory Committee (CPAC) elections for positions with terms that are expiring.

CPACs provide advice and recommendations to the County Land Use Planning entities, including the Planning Department, the Planning Commission and the Board of County Commissioners. CPAC members serve two-year terms.

Each CPAC is divided into neighborhoods. Members represent neighborhoods in which they reside or own property. Residents and/or property owners within the neighborhoods elect CPAC members. There must be at least five voters from each neighborhood to hold an election for the neighborhood. In order to be eligible to vote, you must show either picture identification proving

you live in the CPAC neighborhood where you will cast your ballot or a tax statement proving you own property within the neighborhood where you are voting. You may vote only once in your CPAC area. You must be 18 years or older to vote.

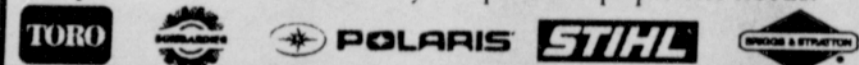

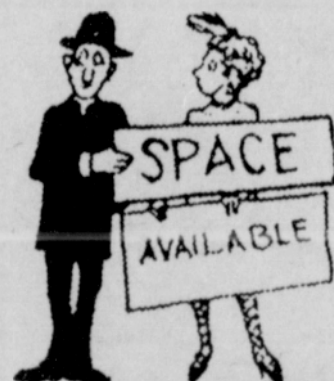
