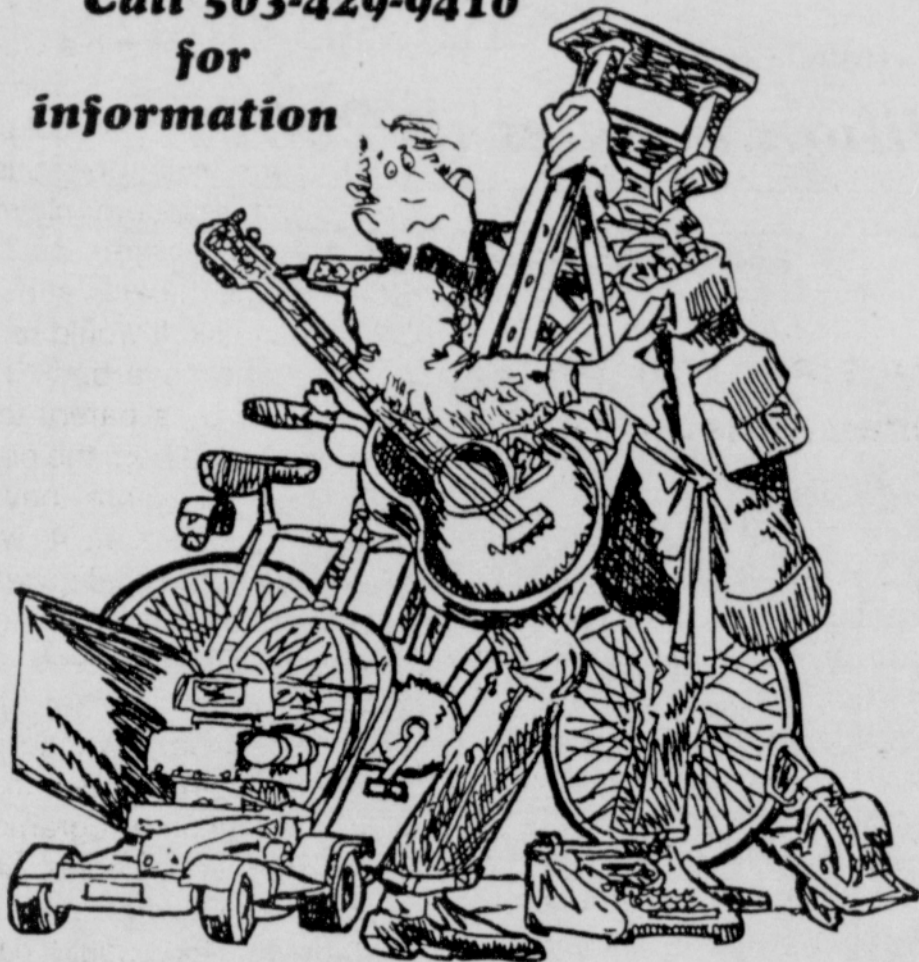

NOTICE OF PUBLIC HEARING

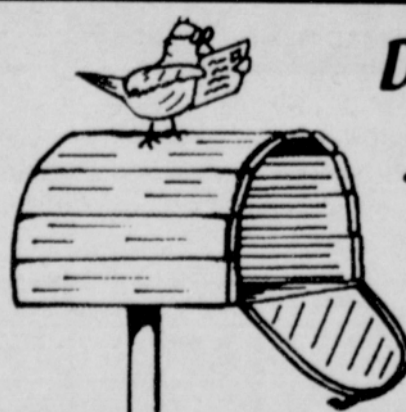
