## Girls found and returned home

Vernonia Police Department, the Douglas County Sheriff's Department and the Roseburg Police Department, located two missing female juveniles in Roseburg. Both girls were reported missing from the Vernonia area.

On March 28, 2003, parents reported the girls missing. Both girls boarded a Greyhound bus in Roseburg on March 28, but did not get off the bus in Portland, where the mother of one girl was waiting for them.

Vernonia officers utilized several sources to track the girls into California, then back

to Roseburg. Douglas County Sheriff's Deputies located the girls, detained them and notified the parents. Both were returned home to the Vernonia area March 31, 2003.

## Man charged with violations of child pornography laws

Vernonia Police Department, the Federal Bureau of Investigation and U.S. Customs arrested Samuel John Brewer, 59, Vernonia, at his Grant Avenue home, April 1, 2003.

The federal grand jury warrant ordered Brewer's arrest on federal charges including possession of child pornography, and transmitting child pornography. The warrant also ordered forfeiture of computer records and equipment. The arrest was made after an investigation that was initiated in 2001.

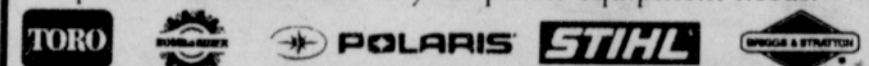

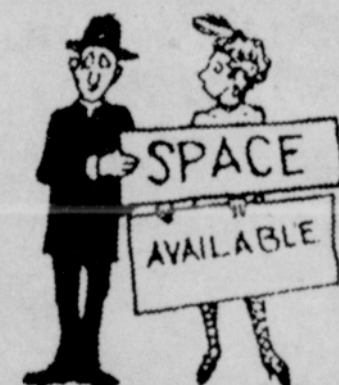
