The organized youth groups of Vernonia continue to use it at no cost to them. Currently we have two Cub Scout, two Girl Scout, and one Boy Scout groups using it weekly. High school groups and youth sports groups have also used it.

To those that are new to the community, a little background on the building. It was first built by volunteers in 1928 for the Camp Fire Girls, later the building was acquired by the city and used by the Boy Scouts and other community activities. In later years, the building was left to deteriorate.

After the flood of 1996, a group of concerned people who did not want to see the building destroyed formed a non-profit organization, called the Friends of the Scout Cabin, and took ownership of the building. The land is leased from the city.

With fundraisers, grants, generous donations, and mostly donated labor by a few dedicated men, the building was enlarged and rebuilt.

The building is equipped with tables, chairs and kitchenware for 100 people. In the summer, there is outdoor furniture for 45.

The rental for the facility is \$25.00 per hour or 6 hours for \$125.00. Full use of the kitchen is an additional \$25.00.

Volunteers do the maintenance of the building, so if you have time to spare, we could use your help. In addition, if you would like to serve on our advisory committee, we would welcome you.
