Decisions for Banks voters

Banks voters have three local option measures to consider on their November 2 ballots. Two of the measures are for residents in the City of Banks; one is for Banks Fire District.

Banks Fire District has earned the support of area residents

Measure 34-82 seeks a five-year levy of \$.62 per \$1,000 of assessed value for operational expenses for Banks Fire District. The levy would not apply until the 2005/06 fiscal year.

Banks Fire District provides fire and emergency medical services—24 hours a day with 60 volunteers—to the communities of Banks, Buxton, Manning and Timber. The district must also responses to emergencies on Hwy. 6, Hwy. 47 and Hwy. 26.

The district's call volume has increased by nearly 70 percent, from 297 in 1999 to 503 in 2003.

This service is a bargain at \$62 per year for \$100,000 of assessed property value. District voters would be wise to vote Yes on Measure 34-82.

Banks Police Department

Measure 34-80 would levy \$2 per \$1,000 of assessed value to help provide law enforcement services. The levy would begin in fiscal year 2005-06 and be in force for four years. The funds can be used only for law enforcement personnel, equipment and services. The only question for voters is to decide whether they want a local police department at a cost of \$200 per \$100,000 of assessed property value. Those who feel it is wise to have a local police department will vote Yes for Measure 34-80.

Banks Parks


Measure 34-84 would provide maintenance and improvements for Banks parks with a four-year levy of \$.75 per \$1,000. This would also begin in fiscal 2005-06. It is very difficult for a small town to operate parks without at least some funding mechanism. If Banks residents want better parks, they will have to raise the money for them.

Banks Mayor and Council

After nearly 20 years of volunteer service for the City of Banks, Mayor Bob Orlowski is stepping down, so voters will also be choosing a new mayor. Two candidates are seeking the mayor's position – City Councilor Terri Branstitre and long-time planning commission member Mike Lyda will both be on the ballot.

Three vacancies on the city council have attracted only two candidates. Ryan Birr is seeking another term. Brian Biehl, whose planning commission term is expiring, has also filed for a seat on the city council.

The INDEPENDENT will not make a recommendation on the mayoral race, but all four of the candidates named above are well qualified and they are all dedicated to helping their community. After the election, there will still be one vacancy on the council and it is obvious that the community would be well served if the candidate who loses in the mayoral race is named to the vacant council seat.
