Notice is hereby given that a public hearing will be held before the Vernonia Planning Commission, at or shortly after 7:00 p.m., on Thursday, November 4, 2004 in the Council Chambers of City Hall, 1001 Bridge Street, Vernonia to consider the application by Ken & Helen Bateman to partition Tax lot, 4404-022-00101, located at 1910 Weed Avenue. Partition of the property would allow the property to be divided into no more than 3 parcels. The staff report on this matter will be available on October 28, 2004, at 4:00 p.m and will be available for public inspection at no cost or can be provided at reasonable cost.

The Public Hearing is governed by Vernonia Ordinance 710, Sections 21 & 22, and ORS 197.763. Failure to raise an issue in a hearing, in person or by letter or failure to provide statements or evidence sufficient to afford the decision-maker an opportunity to respond to the issue precludes appeal to the board based on that issue. Public testimony is welcome, and written statements will be received before the hearing if you cannot attend. All interested persons are invited to attend this meeting and will be given an opportunity to be heard concerning the proposal. Oral testimony should avoid repetition of issues, and should be based on the application or on the approval criteria listed above. If you are unable to attend the hearing, you may submit a written statement to the City Planner on or before the hearing date. Telephone conversations cannot be accepted as testimony. Pursuant to ORS 197.763, failure to raise an issue at the final evidentiary hearing, or by close of the record, in person or by letter, or failure to provide statements or evidence sufficient to afford the decision maker an opportunity to respond to the issue precludes appeal to the Land Use Board of Appeals based on that issue.

The meeting location is accessible to persons with disabilities.
