

Corsiglia named to Resource Advisory Committee

Columbia County Commissioner Joe Corsiglia has been appointed to the Salem District Resource Advisory Committee (RAC) by U.S. Department of Interior Secretary Gail Norton. Janet Wright, Assistant to the Columbia County Board of Commissioners, was appointed as alternate to the committee.

"I am honored to have been appointed to the RAC and I look forward to enhancing Columbia County's position in regards to its investment in public lands," said Corsiglia.

The purpose of the RAC is to

improve collaborative relationships between the Bureau of Land Management (BLM) and local communities and make recommendations to the Secretary of the Interior on projects that benefit federally-owned forest lands, consistent with the provisions of the Secure Rural School and Community Self-Determination Act of 2000. The Act calls for the establishment of a RAC for local oversight of federally owned forest lands, and sets a five-year payment schedule to communities in lieu of funds from timber harvest.

The RAC is a mechanism for local input between BLM and the County to assure that land management practices benefit and enhance forest resources.

Columbia County has received \$152,300 under Title II of the Act for a variety of forest and stream enhancement projects, including the CZ Trail Crossings, Scappoose-Vernonia Road Overlay, and Pisgah Home Road improvement.

The committee oversees funding opportunities for projects to further watershed protection, fish-friendly passage and that enhance and maintain forest. It also provides interested parties a venue to participate openly and meaningfully in the early stages of project development.

Council approves street vacation, holds Parks planning workshop

After convening the May 16 Vernonia City Council meeting, Mayor Sally Harrison first opened a brief public hearing on a request by James and Kathy Morrison to vacate a portion of 2nd Street.

Presenting the staff report, City Planner Julie Steffen said that the vacated portion was not expected to ever be used for a street and that 100 percent of neighbors approved the request.

Citizen Jerry Keenon spoke in favor of the vacation, saying it would improve water flow to the residents in the area when the water line is upgraded as proposed. No one spoke in opposition to the vacation and the public hearing was closed.

After reconvening, council voted unanimously to approve the ordinance vacating the designated portion of 2nd St.

The meeting was then ad-

journed to go into the Parks Master Plan Workshop. During the workshop, all attendees were invited to write on large pieces of paper posted on the walls around the room what they liked, disliked and would like to see improved, about each city park. The information gathered will be used by the Parks Committee to put together an updated Parks Master Plan, to be released this fall. The last Master Plan was done in 1999.

City Administrator Robyn Bassett reviewed some of the comments, including more parking at Anderson Park and using the Airport for fireworks. There will be a part time Park person starting in July, she said, but without increased funds, that won't be enough to maintain the parks.

The next meeting will be June 6, 7:00 p.m. at City Hall.
