The April 24, 1986, issue of The Independent included the following news story on page 5:

The Jamboree committee's request for use of School District 47J properties during the 30th Jamboree was not approved at the district's April meeting, in the absence of Jamboree representatives. The matter will be reviewed at the May meeting.

Most critical to the Jamboree has been finding an acceptable site for the carnival. Sue Cavinee reported that the carnival had committed to the Jamboree upon the assurance that either the school property or the new city hall site at the corner of Weed and Maple streets will be available.

The school property is most desirable for a number of reasons, paramount of which is that the city hall site needs leveling and surfacing work to be usable.

In other developments, Mario Leonetti, chairman of the concessions committee, revealed plans for tightening up the procedures and regulations for issuing permits and controlling the operations of vendors.

"County health officials," he declared, "have been asking to inspect all food vendors on site.

"Care will be exercised to prevent vendors from sneaking in late to avoid inspections and fees," he continued.

A matter of serious concern to all community celebrations, including Jamboree, surfaced in a report by Fred Klinger, who reported that the liability insurance quotation for this year's event was between \$2000 and \$2,500, with no guarantee that it would not be higher by August 1. Last year's premium was in the \$600 range. An increase of 400% or more threatens to eliminate community celebrations. The executive board will research the matter and make a recommendation to the next meeting.

Consumer protections for financial products are not so different than consumer protections for household goods. Not all Americans are certified electricians — the average person probably can't tell if his or her toaster has faulty wiring. But the Consumer Products Safety Commission does employ experts who can test toasters and make sure they won't burn your

house down.

The reality is that when the Consumer Products Safety Commission cracks down on such a dangerous product, the only companies that are hurt are those selling toasters that burst into flames. Responsible appliance companies that manufacture safe products aren't hurt in the least. In fact, the knowledge that a consumer

Beware of this new property tax scam

Be careful of companies with official-sound names offering to help you reduce your property taxes for a fee. There is no need to pay for such services. Misleading mailers can look like official government agency

documents. The mailers seek to trick you into sending them money to lower your property taxes. They also use addresses like "Regional Processing Center" to make you think the mail is coming from a government agency. A recent mailing reported to the Oregon Department of Justice includes the misleadingly official-sounds title: "2010 Property Tax Reduction Form."

Sometimes, mailers threaten to impose a late fee if you don't send them money by a certain date.

Don't be fooled. Government agencies don't charge for tax reassessment — it's free. If your property has declined in value and you think your property tax is incorrect, you can request a review of your property from your local tax assessor. For more information, contact your county tax assessor's office.

What you can do to avoid becoming a victim:

 \cdot Don't pay money for something you did not ask for.

· Contact your county assessor's office directly, don't pay for a middleman.
