The [Vernonia] Independent recently interviewed candidates in the May 18 primary for Columbia County Commissioner. Two of the Democrats are Judith Taylor and Russ Moon both members of the Rainier City Council.

One question posed to the candidates was: "What will you do to keep operating with less money?"

Judith Taylor offered the following:

"I know the budget is the biggest item right now. We have to prioritize...We need to look at the budget at a line item level and see what we can do with what we have and what we can do without."

Mrs. Taylor clearly recognizes the central concern facing Columbia County - the budget - and displays a clear understanding that the county commissioners need to scrutinize and prioritize any proposed expenditures.


