 the victim of a burglary to arrest an individual who was selling items stolen from the victim's residence. The victim had been alerted to the suspect by a local archery shop after the suspect attempted to sell some stolen bows at the shop. The victim worked with the Sheriff's Office to set up a "buy" from the suspect. The suspect attempted to sell the property (unwittingly) back to the victim. Sheriff's Deputies in waiting converged on the suspect and took him into custody near milepost 53 on Highway 30. At the time of arrest he was also found to be in possession of Methamphetamine.

These cases point out the difficulty we have in responding immediately to criminal events county wide, but also the willingness
