Opportunity to Comment Proposed No Further Action

Proposal: Pursuant to Oregon Revised Statute (ORS) 465.315, the Oregon Department of Environmental Quality (DEQ) is proposing to issue a No Further Action (NFA) determination for the former Bair Logging Company site, a 1.5 acre property encompassing a city block located southwest of the intersection of Maple St and Weed Ave in Vernonia, Oregon. The site is also proposed for de-listing from the Confirmed Release List.

The Voluntary Cleanup Program has reviewed assessment and cleanup activities performed at the site. The site has been developed since at least 1928. Historic uses include a logging company, temporary storage of flood debris, and temporary housing for flood victims in 2008. The site is currently being redeveloped.

Contamination issues at the site included impacts from releases at a bulk plant located north of the site, possible elevated levels of arsenic in soil, and impacts

from an old railroad spur. Based on the results of the assessments performed to evaluate these issues, additional cleanup is not required at the site.

Upon written request by ten or more persons or by a group with a membership of 10 or more, a public meeting will be held to receive verbal comments.

The Next step: DEQ will consider all public comments received before making a final decision regarding the "No Further Action" determination.
