

# Vernonian jailed for attempted murder after firing gun

Sally Ann Lee, 57, Vernonia, was arrested August 21, at Lee's U-Catch Trout Farm on Hwy. 47 S, for attempted murder, menacing, assault with a firearm, and reckless endangering.

Lee's brother, Tom Lee, called 9-1-1 to report that his sister was intoxicated and shooting a gun. The Columbia County Sheriff's Office (CCSO) responded, along with St. He-

lens Police, Clatskanie Police, OSP, Columbia City Police, Washington County Sheriff's Office, Vernonia Fire Department and Metro West Ambulance.

CCSO recovered evidence of at least four shots having been fired from a rifle. Investigators believe the situation started as a family squabble relating to foreclosure proceedings on the house where Sally

Lee resides. Lee was arrested currently in the CCSO jail without further incident and is awaiting proceedings.
