I live on Fishhawk Lake and several years ago, came within a hair's breadth of losing our beloved Golden Retriever, Jenna, because she ate salmon that spawn up there in the creeks every year. I took her into the vet's office in Hillsboro, who misdiagnosed her initially (we've changed vets since). This is why I am writing this, because the symptoms can easily present as any number of OTHER diagnoses...and time is of the essence in saving our pets after they've eaten salmon, and MUST be correctly diagnosed quickly. If a veterinarian doesn't often see this, or is not aware of the travelling someone has done near a river or other waters during salmon spawning season (as an example), then you, as the dog own-

er have to be their advocate and let them know that it could be from eating salmon!

I list and sell real estate at Fishhawk Lake and tell all of my clients who have dogs about this hazard and have an article of my own about it on one of my websites, too. You have to also be especially aware of puppies doing the same thing (my young Golden Retriever pup got into salmon during a long spawning season and I'm thankful to Dr. Goza's office and the Vernonia Pharmacy for having the antibiotics readily handy for me to get ahold of quickly and thus saving his life). Time is of the essence in saving your dog's life.

I would recommend that this article be resurrected every year as salmon spawning begins.

To the Editor:



2012. We also circle back with the agencies to make sure that legislation already passed is being implemented properly. Since our legislature is not full-time, we need these opportunities to collect data, discuss options for possible solutions and draft appropriate legislation.

A case in point is the current difficulty being experienced by participants in the Senior Tax Deferral Program. Under the program, the state pays the property taxes for qualified applicants, and then the state is paid back when the property is sold or the person dies and their estate pays the deferred property taxes plus interest. This program is designed to be self-funding, but the current housing crisis has created havoc with the process and it is now \$19 million in the hole.

In order to protect the long-term viability of the program, the legislature passed HB 2453 last session, which requires reapplication every two years, imposes a house value "test," and discontinues participation by those who hold a reverse mortgage. The House Revenue Committee has asked the Department of Revenue to prepare a
