Did You Know?

Over the past several years the Vernonia Police Department has received numerous complaints about the use of Un-muffled Engine Braking throughout the city. The Oregon Revised Statutes (811.492) state that "A person commits the Offense of Engine Braking if the person is operating a motor vehicle on a highway and uses un-muffled engine brake."

This offense is a Class (A) Violation and the driver could be issued a citation with a presumptive fine of \$435.00. Due to the numerous complaints, the Vernonia Police Department will issue citations when officers observe this violation.
