On Saturday evening H. S. Naylor and
Blanche Underwood arrived here, com-
ing on the N. Yamhill stage. They
went to the Larsen House where Mr.
Naylor registered for both as if living in
N. Yamhill. On being questioned, he
changed the register so it appeared that
they hailed from Portland.
They were assigned separate rooms and
retired saying they wished no supper,
but Mr. Naylor procured some oysters
and beer which they were found enjoying
a little later on in the evening, both in
the same room. Mr. Naylor seemed
slightly intoxicated, and from some of
their actions the hostess became suspicious
that something was wrong and

had been treated at the other house.
The girl is a good-looking brunette,
apparently 16 years of age, and said her
parents would come shortly. They came
on Monday and the whole party went
towards Bay City. Parties who claim to
know them, say they all reside at Forest
Grove.
There may be nothing wrong, but
their actions were rather queer to say the

such that it threw suspicion on the girl,

Teachers' Examination.
The following named persons were ex-
amined as applicants for teachers' licenses
last week: Miss Lillie M. Wiley, Ida
Pagenkopf, Alice Thacker, Lillie Law-
rence, Alma Lawson, and Minnie Cobb.
Misses Pagenkopf, Lawson and Cobb
were granted third grade certificates, the
others failing.

In this connection we wish to point out
some of the weak points of the Oregon
school law. An examination of itself is
not a sufficient test of a teacher's ability
at any rate, and the school law of this
state is positively unfair and does not
meet the purpose intended by any means.
The clause in the law requiring a
teacher to raise the grade of his certifi-
cate every time he is examined, is the
objectionable feature. In the examina-
tion referred to, Miss Lillie Lawrence
raised her average percentage quite large-
ly and lacked only a fraction of having
an average of 80 which is required for a
second grade. As it is she is debarred
from receiving even a third grade, while
teachers just beginning, having little or
no experience, with a much less average
and less advancement in the average, are
granted third grade certificates and
turned loose on the community to
"teach the young idea how to shoot."

The law requires an average of 70 for
a third grade, 80 for a second grade, and
90 for a first grade license, and when a
third or second grade certificate expires,
the applicant must raise the grade or be
shut out, so the injustice to the teacher
as well as the community can readily be
seen. For instance, if a teacher holds a
third grade with an average of 79 and
raises the average to 80, a second grade
is granted, or if it is the first examination
and the average only 70, a third grade is
issued, while on the other hand, a
successful teacher holding an average of
80 and raising it to 89 1/4 is not allowed
to teach any longer. But this does not
debar inferior teachers from going from
one county to another and engaging in
the profession over good teachers un-
justly shut out.

This law should be changed at the
next session of the legislature.
