The Census office will soon publish a report of interest to all lumbermen, on the production, consumption, etc., of lumber in the three great White Pine states, Michigan, Wisconsin and Minnesota. The report will show wonderful growth and development in these states since the census of 1880. It is but fair to reason— from what has been accomplished elsewhere—to a conclusion that Pacific Coast lumbermen have good grounds for faith in a future that is "big with promise." The report mentioned states that the large mills and timber owners from whom returns have been received state they have only enough available timber to last them five years. MORE ASTORIA RAILROADS.

On February 23d, last, the following articles of incorporation were filed with the secretary of state, but they were not published at the time, as the incorporators requested that they be withheld from the press, for purposes (perhaps right of way) better known to themselves. And now after so long a time the company has done nothing. Here is a resume of the objects, etc., of the corporation, which took for its name that of the Pacific & Eastern Railway company. Incorporators, Frank J. Taylor, M. J. Kinney, H. G. Van Dusen; principal office, Astoria; capital stock, \$10,000,000, divided into 100,000 shares. The declared object of the company is to build a railway south from Astoria to and up the Tillamook river; then across the Coast range to the headwaters of the Yamhill river and down said river to the east side of the Coast mountains; thence south through the Willamette valley to Springfield; thence easterly, crossing the Cascades by way of the middle fork of the Willamette to east of the Cascades; and thence easterly by way of Harney lake valley and Eastern Oregon and through Southern Idaho to Salt Lake City, Utah, also a line from Astoria to Portland and thence south through the Willamette valley to a practicable connection with the main line. This piece of railroad "news" is now given to the public for the first time.—Statesman.

With no time for folly or gossip, with no desire for other enjoyment than that found in the conscientiousness of honest and intelligent effort to earn a living and raise her children, she toiled on and on for years, her only recreation an occasional outing, and an hour with her violin on which she was a skillful performer—and now she lies stiff and cold and pulseless, and the world goes on, and everything has to be done, and type set, move every turn, the sight of everything in the office and around it recalls the memory—is a grand monument than massive marble columns could ever hope to grant.

Tillamook's First Annual Fair.

RACE PROGRAMME.

BEGINNING SEPTEMBER 1ST, AND LASTING THREE DAYS.

PREMIUMS TO BE OFFERED.

Extensive Preparations are being made by the Tillamook Fair Association and a Grand Time is Expected.

To THE PEOPLE OF TILLAMOOK:—The Directors of the Tillamook Fair Association in presenting this catalogue of their projected Annual Fair, deplore the fact that the premiums offered and purses are not as numerous or as large as might be desired. The Association has come to stay, however, and does not propose to bite off more than it can chew. It expects to expend in premiums and incidental expenses as much, if not more, than it will receive.

The Association was not organized to make money for any man or any of the stock-holders, but to afford a place where our little county fair can be held annually; where all of our people can come for a few days' camping-out and social recreation, and where the products and stock of our country can be brought together for examination and comparison. In case the people are liberal and generous in their support, we shall do better in the future.

Where no money premiums are offered, blue and red ribbons will be awarded for first and second premiums.

The catalogue of the Tillamook Fair Association for the First Annual Fair, to be held at Tillamook City, Tillamook County, Oregon, commencing on the 1st day of September, 1891, to continue three days is as follows:

PROGRAMME OF RACES.

1st DAY.

Tuesday September 1st.
1. Running race, free for all, 600 yards and repeat; purse \$50; entrance \$20, added.

2. Trotting race for 2-year-olds; 1/2 mile and repeat; purse \$25; entrance \$15, added.

3. Trotting race, gentlemen's buggy horses, 1/2 mile; entrance \$5 to make purse. Association will add buggy robe for first horse, and whip for last horse. Horses to have been owned three months in Tillamook county, and to be driven by owners.

2nd DAY.

Wednesday Sept. 2nd.
4. Pony race, 14 hands or under; 440 yards and repeat; purse \$30; entrance \$5, added.

5. Running race, for two-year-old Tillamook bred horses; 1/2 mile single dash; purse \$25; entrance \$10, added.

6. Running race, free for all; 1/2 mile and repeat; purse \$50; entrance \$20, added.

7. Best display of lady equestrianism, \$5; second best \$2.50.

3rd DAY.

Thursday Sept. 3rd.
8. Trotting race, free for all; one mile; purse \$25; entrance \$15, added.

9. Running race, free for all; one mile, single dash; purse \$50; entrance \$20, added.

10. Consolation purse, \$15; best two in three, 440 yards. For horses that have taken no part of purses.

RULES.

In all races three to enter and two to start are required.

No money given for a walk-over. Running races will be conducted according to the rules of the Pacific Blood Horse association; trotting races, according to the rules of the National Trotting Association.

In races for less than 1/2 mile the distance flag shall be ninety feet.

All purses shall be divided, two-thirds to winner, and one-third to second.

In the one mile trotting race, if the race does not fill, any horse entering and trotting in 2:40, or better, shall be entitled to the purse.

Admission Free.—50c. per day, or \$1.00 for season. Ladies, half price.
