### SUITS THE RING ORGANS.

[From Salem Capital Journal.]

The following has been published in the Woodburn Independent, and is no doubt very gratifying to those persons, if there are any such, who are interested in not having the proceedings of the county court made public:

The self-styled newspaper men who worked as lobbyists during the last session of the state legislature and secured the passage of a bill providing that each county court in the state shall select two papers of largest circulation in the county in which to publish the court proceedings, are willing to sell out cheap now. The act provides that not more than 50 cents per "square" (about one inch of space), should be paid for such publication. This sum would have been good pay for printing what real newspapers are willing to publish as news. But the act did not prescribe the minimum sum to be paid, and several county courts have fixed the price at 1 cent per square. The greedy papers can take this or let it alone, as they please.—Oregonian.

No effort has been made in this county to have the law complied with at a reasonable rate. Regardless of the Oregonian or its echoes, regardless of the action of the county court, which seeks to nullify the law, THE JOURNAL believes in the full light of publicity on the proceedings of the county court and its expenditure.

THE JOURNAL has published the proceedings according to the law, and has called for a certified list of the claims presented to the court for allowance at each monthly session and publishes the same, and shall continue to do so, whether it receives reasonable compensation or not. The law is mandatory upon the court and the publisher. The court must cause its proceedings and claims allowed or disallowed to be made out and published. The publisher must print. There lies the only public protection. The technicality taken advantage of by this court of this county by fixing the pay at one cent per square, which pleases the Oregonian so, is only a quibble. It is a trick to prevent the publication of its own proceedings. But it will no work. The law intends a reasonable compensation, not over 50 cents a square. The expense of the law is nothing as compared with the huge steals perpetrated in this county in the absence of any such law. This county has paid enough in stealings on one job to defray all the expense of this law for ten years, and will again if the ring can cover its tracks. The people of this county believe the bills allowed by the court should be made public. That is the surest way to prevent jobbery and corruption and plundering of the county treasury.
