BLAINE DYING

THE GREAT STATESMAN NEARING
THE END.

His Physicians Say he is in the Last Stages
of Bright's Disease.

Dr. Johnson, Blaine's physician, with
the concurrence of the family, gives the
following statement to the press: Blaine
has been suffering some time with
symptoms which impaired his general
health, but which did not clearly indicate
a disease of any particular organ.
Evidences of local organic disease were
manifested recently, and it is believed
the present condition is due to this cause.
While there is nothing in the nature of
this disease to warrant a fear of any
rapid progress, he has shown within the
past month more signs of serious illness
than before. It is to be hoped this
aggravation may pass off, but no positive
statement can be made as to the changes
which may take place from day to day.
At the present moment he is better than
for a week past. "Blaine is just a little
better, but no great change in his condi-
tion this afternoon," was said at the
house on inquiry.

WASHINGTON, Dec. 18.—Jas. G. Blaine,
Jr., said to reporters at 6.30 this evening:
"We think that father is considerably
better than he was this morning. He was
dangerously ill during the forenoon. Dur-
ing the afternoon he seems to have
rallied somewhat. The physicians have
been here this evening, and we now
think that he will live throughout the
night, and we hope for the best; still, it
must be said that he is very danger-
ously ill." These were the strongest
statements that had yet been made by
the family or physicians as to the condi-
tion of the ex-secretary. President
Harrison, accompanied by his Private
Secretary, Halford, walked over from the
White House to the ex-secretary's resi-
dence this evening to personally inquire as
to his condition and expressed relief and
gratification at being informed that
there had been some abatement of the
more alarming symptoms. The excite-
ment throughout the city was intense as
the news of Mr. Blaine's condition spread
and Sunday, though it was, the news-
papers issued extras, which found a
rapid sale.

Timber Land Decision.

ST. HELEN, ORE., Dec. 14.—Muckle
Brothers received notice a few days ago
that the commissioner of the United
States land office at Washington had
confirmed the decision of the local land
office at Vancouver, Washington, relative
to timber land which the firm purchased
in Cowlitz county a few years ago. It
was claimed by Cleveland's special land
agent that irregularity existed in the way
land was purchased by Muckle Brothers
and also that the land was more valuable
for agriculture than timber, hence could
not be taken under the timber land act
of June 3, 1878. The matter was brought
before the district land office at Van-
couver, where it was decided in favor of
the purchasers. An appeal was then
taken to the general land office at Wash-

James Carothers and F. M. Wallace of
Mansfield, O., fought with bare knuckles
for the right to court a girl unmolested.
Carothers gave up in the fifth round.

A number of the firms manufacturing
the cheaper grades of jewelry in Provi-
dence and Attleboro are on the verge of
bankruptcy on account of numerous
failures in the trade in the West during
the past week.

Frakeman Frank Gorman, who caused
the wreck on the New York and New
England road on Saturday near Provi-
dence, R. I., has been let off with a dis-
missal. Gorman's excuse was that he
was sleepy from overwork.

Chicago Typographical Union No. 16
has adopted resolutions protesting
against the awarding of the contract for
printing the World's Fair catalogues to
the W. H. Conkey Company on the
ground that they employ non-union
labor.

Bishop Paret of the Protestant Episco-
pal diocese of Maryland and the District
of Columbia will soon have built a
steamer, the inside of which will be
fitted as a church, to carry him and his

James Still, the colored boy who is an
inmate of the Jamesbury (S. J.) Reform
School, yesterday reached the sixty-
fifth day of his wonderful fast. He can-
not retain anything on his stomach, and
although he weighed only seventy
pounds when admitted to the hospital
at the school it is now said he weighs
over 130 pounds.

E. J. Wilbur's sawmill at Meacham,
Oregon, was completely wrecked recently
by the breaking of the fly wheel on the
engine. The accident was caused by one
of the belts breaking and striking the
governor, rendering the engine unman-
ageable. The throttle valve was also
bent, so that the steam could not be
turned off, and the engine attained such
a terrific speed that the men all left the
mill. Soon after the wheel burst, wreck-
ing the mill, and scattering fragments of
iron all over the place.

ALBANY, Ore., Dec. 16.—About 5 o'clock
this morning, as Fred Reis was coming
from the depot on Lyon street, he saw a
meteor approaching from the south-
east. Its descent was very rapid, and
with a rushing sound it fell obliquely in
the street, followed by a wake of bright
sparks. Reis hastened to where it fell,
and dug it out. It was still very hot,
and he carried it home on a piece of
board. The stone retained its heat to a
wonderful degree and charred the board
upon which it was placed. The stone in
appearance resembles a piece of reddish
brown clay that had been burned, rather
than stone. It is not very hard and
looks like volcanic production. It was
broken into one piece was sent to
Portland to be analyzed. The stone is
not heavy, and evidently had been sub-
jected to great heat.

LIMA, O., Dec. 17.—John Ennison,
proprietor of the large mills at Bluffton,
Ohio, has lately been troubled with the
apparition of his dead wife. The vision
has made him take to drink and to con-
fess all the little things he ever did to
anger his wife. He has even gone so far
as to place an annuity on his dead wife's
sister in order to appease the wrath of
the wraith. Last night, intoxicated, he
started out with the revolver to lay for
the ghost. The ghost appeared and he
fired. A human cry responded to the
shot, and upon servants rushing on the
scene, the wounded form of Charles
Sheldon, the night operator for a rail-
road company, was found. Sheldon was
severely, but not fatally, injured. The
moment Ennison learned that he had
shot Sheldon, he disappeared and has
not been seen since. Sheldon refuses to
say why he played such pranks, and
there is a general impression that Shel-
don adopted the unique means to force
tardy justice to some one who is at present
unknown. The local authorities have
taken the matter up, and threaten to
imprison Sheldon when he gets well un-
less he confesses.

A Novel Murder.

RICHMOND, Va., Dec. 19.—A novel
method was adopted to commit a double
murder in Henrico county. The crime
involves a story of a divorced man in
love with the wife of another, his love
reciprocated and the husband and his
best friend in the way of the full and
complete enjoyment of the mutual attach-
ment.

Seven miles west of Richmond, on
James River, there have lived in the
same house for a few years three farmers
named Philip L. Nicholas, James Mills
and Judson Wilkinson. For some time
the relations of Nicholas, who was
divorced from his wife, and Mrs. Mills
were unduly intimate. Mills appeared
to think very highly of Nicholas.

Last Thursday when he and Wilkin-
son were invited by Nicholas to go across
the river to cut a bee tree which he said
he had discovered Mills gladly accepted
the invitation as did also Wilkinson.
Not very long after the party left Nicholas
returned with his clothes soaking wet
and announced to Mrs. Mills and Wilkin-
son's mother, the only other occupants
of the building, that the boat had cap-
sized and all had fallen into the water.
He said he was the only one that could
swim and his companions were drowned.

Mrs. Mills accepted the story as true,
but not so Mrs. Wilkinson. Neighbors
and officers of the law began to investi-
gate and this morning the man was
arrested on a charge of double murder.
The boat was found in the river, and
when it was taken out of the water two
freshly bored auger holes were found in
the bottom.

A short distance down the stream two
cornucopias trimmed so as to exactly fill
the holes in the bottom of the boat were
found. In Nicholas room an auger that
filled the bored spaces was discovered.

The theory is that Nicholas being
aware that neither of the men could
swim, determined to dispose of them by
drowning and prepared the boat so as to
sink it in midstream, knowing that he
could save himself. It is supposed that
he thought Wilkinson knew too much
of his intimacy with Mrs. Mills, and
therefore decided that two persons who
could not swim could be as easily
drowned as one.

The accused will have a preliminary
hearing tomorrow.

Of Interest to Settlers.

Representative Hermann has intro-
duced and is pressing before the commit-
tee on public lands, a bill enlarging the
powers of the United States commis-
sioners. The bill provides that persons hav-
ing homestead proofs may make them
before these commissioners. At present
the homesteader is compelled to make
final proof before United States land
officers at the local offices or before clerks
of court at the county seat. Mr. Her-
mann declares that this new provision
would be of great advantage to many
settlers who live a long distance from
county seats or from the local land
offices.

Souvenir Half Dollars.

PHILADELPHIA, Dec. 16.—The first 50-
000 of the World's Fair souvenir half-
dollars were shipped to Chicago today
by express in care of the United States
subtreasury. They occupied five kegs,
and include all the first 50,000 minted,
except No. 1, for which the exposition
company is to get \$10,000, and three
others numbered 400, 1402 and 1892.
These, on account of their extra value,
estimated to aggregate \$15,000 were care-
fully put up in separate packages, and
packed in a special keg by themselves.
They will go forward by the United
States express.

Disease in Mexico.

CINCINNATI, Dec. 19.—Health officer J.
W. Pendergast is back from a trip through
Mexico. He says the country is a big
hospital, typhus fever being epidemic.
In the City of Mexico the deaths from
smallpox average forty and fifty a day.
Nothing is done to check the epidemic
and the disease has full sway.

At last 50 per cent. of the population
have been stricken. Women carry their
smallpox stricken children to the depots
and other public places without let or
hindrance. Leprosy is not infrequent
and other diseases run riot.

Back in the Fold.

ROME, Dec. 16.—A statement in regard
to the settlement of the difference be-
tween the church and Rev. Father Mc-
Glynn, of New York, has received full
confirmation. The news of reconciliation
produced the happiest impression at the
Vatican, where Father McGlynn has al-
ways been a favorite.
