DESPERATE FIGHT.

FOUR MEN ATTEMPT TO TAKE A
TRAIN IN TENNESSEE.The Sheriff and one Desperado killed.—
Others Wounded.

JELICO, Tenn., March 18.—Four desperadoes attempted to take the Louisville & Nashville southbound train this morning twelve miles south of here. Conductor Brown called on Sheriff Burnett and Deputy Dall, who happened to be in another car, to preserve the peace. The officers repositioned, and a pitched battle ensued in the smoking car. When the smoke lifted, Sheriff Burnett was found dead, the deputy shot in the head and one desperado fatally wounded. Dall was then overpowered and thrown from the train, but managed to grasp his gun and he wounded one and effected the arrest of another, permitting two to escape. Although internally injured and suffering great agony, Deputy Dall took the prisoner to Careyville. At this place the wounded desperado was thrown on the platform to die, while the other was taken on to jail at Jackboro. He will not live to see daylight, as the people are greatly excited, and declare that crime must be put down in a quick way.

The New Game Law.

Senator Gate's fish and game bill (No. 86) was filed by the governor. It punishes the use of sink boxes, batteries, swivel or pivot guns, either from shore or boat or rafts, blinds (except 100 feet from the shores of lakes) hunting between sundown and sunrise (except on grain-fields and generally in Curry county); offering for sale or killing grouse, pheasant, quail, all ring-necked, China, silver, golden, copper or green Japanese pheasant, bob-white, jack-snipe or prairie chicken, except between October 15th and November 15, and except that prairie chicken may be in July, August and September, and except that no quail, bob-white or pheasant may be any time killed east of the Cascades—by a fine of \$15 to \$100 and costs, or equivalent imprisonment. The penalty is extended to transportation of the birds, except alive for exhibitory or propagation purposes. Wild ducks, geese and swan may only be sold in November and December; trout only in September and October. Deer must not be hunted between December 1 and August 1, or from an hour after sunset until a half hour before sunrise of any day, or in any case unless the carcass is used for food. Moose, elk and mountain sheep may not be taken between December 1 and August 1, or at any time for their skins, hides, horns or hams. These parts must at no time be sold or transported. The animals themselves must not be held in custody during close season, and the possession of a hide or skin is prima facie evidence of having killed the animal. One half of all fines go to the informer, and concurrent jurisdiction is given to justices of the peace.

The idea of moving the capital of a state because of an attack on the legislature by a local paper is original with the California legislature. If generally adopted the state capitals would be continually on the move.

Colonel Webster of New York City looks like the vitalized product of terrapin, green turtle and rich old port. He is a good liver, an excellent raconteur and a vigorous debater. He and Secretary of the Treasury Carlisle were chums in Kentucky when the only tightness of money that ever worried Carlisle was when he held a full hand and had no more cash to raise the bet of his opponent.

Shorts.

The libel suit against the Astorian has been dismissed.

Congressman Blount of Georgia has been sent to Hawaii to investigate the state of affairs before anything is done towards annexation.

There is yet considerable doubt as to whether the gubernatorial appointees as senators from Washington, Montana and Wyoming will be seated.

The Washington Legislature adjourned sine die last Thursday night without electing a Senator, having balloted more than 100 times. They appropriated \$1,000,000 for a State house.

The clock on the high-school building at Colorado Springs, Col., will be arranged so as not to strike after dark. The local papers do not state the reason for this, so one is left to suppose that it is either to prevent the wear and tear of the clock or to avoid waking the night police.

There are no women in the State prison at Salem at present. About half the inmates come from Multnomah county. There are twenty-eight life men there. They are the best behaved prisoners. The prisoners will nearly all be idle for two years, until the jute mill is completed.

Corbett and Mitchell have been offered \$80,000, but they expect a larger purse. This is putting a big price on brute force. If a presidential candidate should make such bombastic assertion regarding his contest as Corbett made regarding the coming fight, he would be drummed out of the country.

The Burns stage line has been tied up since last Thursday and the mail is scattered all the way from Liano to Drewsey. This line, says the Vale Gazette, has periodical tie-ups, and is an unfortunate enterprise. Such service is not only a detriment to the people but an injury to the country.

A Klamath county exchange tells this little district school incident: When the word "husband" was put on the black-board none of the children could pronounce it, and in order to help them out the teacher asked: "What would I have if I should get married?" The answer was prompt but not what she expected, and she blushed such a brilliant red that the sunlight paled.

Clackamas county has a peculiar case on hand. The Oregon City Express says: C. D. and D. C. Latourette, attorneys, submitted a proposition to collect the tax due upon a mortgage given by the Willamette Transportation and Lock Co. to Elijah Smith for 30 per cent. of the tax collected, said fee to be contingent upon the collection of the tax which amounts to about \$5250, the county to bear the court costs. The proposition was accepted.

Hillsboro Independent: There has been an offer of seventy cents a roll for all the butter made at Craig creamery, to be delivered at the nearest railroad station, by a Chicago firm; and another call for 200 pounds a week down the Columbia river. After the Oregon Rip Van Winkles sleep another hundred years they may wake up to the fact that Washington county can make butter that has a ready sale. All of Western Oregon, Tillamook county and all along the coast, can't be surpassed for dairying.

We don't want to be too inquisitive about matters that do not really concern us, but we have been haunted for some days with the proposition: How will ladies wearing hoops be able to ride on horse back? To sit sideways would make the load appear too much one side, and to ride a la clothespin, Great Scotland! it can't be done. The ladies of California are wearing divided dress skirts in riding, but how they will dodge the hoopskirts and continue their healthful exercise, we know not.—Sheridan Courier.

The Cleveland cabinet averages up pretty well in avordupois. The combined weight of the eight members is, according to the most reliable data at hand, 1,555 pound, or an average of 193 pounds. Mr. Bissel is the heavy weight, tipping the beam at 325; Hoke Smith is the next heaviest with 225 pounds; Colonel Herbert, 180. Mr. Olney, 165; Mr. Carlisle, 160; Judge Gresham, 160; Mr. Morton, 170, and Colonel Lamont, 150. The average weight of the previous cabinet was 165.

There were sixty-five voting machines used at the various town elections in New York State Tuesday. Reports that have been received of their achievements are uniformly favorable.

Over fifty saloons have gone out of business since the first of the year in Portland, and a wholesale liquor dealer says he thinks many more will close April 1st, and he favors a license of \$400 a quarter, so that there may be still fewer saloons. He thinks it would be better for the business to shut up the little concerns.

The Columbian souvenir half dollar which many publishers have accepted for World's Fair advertising at one dollar each, has proved a hoodoo. Of the entire issue, valued by the Columbian Exposition directors at \$5,000,000, just \$827,000 worth of the pretty pieces have been sold. The balance is left in kegs in the safety vaults. Some how or other the coins do not seem to take. The great demand for them which was so confidently expected has failed to materialize, and it is not at all improbable that in the near future the price will drop one dollar to their face value, or at least near it. If the price is reduced it will certainly be a great injustice to the many thousands of people who have purchased them at the advanced price.—West Side Independence.
