THRIVES AT ANY RATE

The Portland Sun which is very fair to all sections of Oregon has this to say in one of its editorials: "As a region of country becomes thickly settled, the desire of the inhabitants for a railroad is natural and reasonable. A railroad is a modern necessity to a section of country capable of supporting a large population and yielding a large amount and variety of products. Hence, the 'iron horse' has penetrated most fertile localities not long after their settlement, making the people of each neighbor again with those of the localities left, however far away. A town without a railroad is in a sense 'out of the world.'"

"Yet it is true that the advent of a railroad sometimes injures a town more than it does it good; and that some of the most prosperous and happy settlements are those which the scream of an engine's whistle never reaches."

"Such, for example, from all accounts, is Tillamook county, just over the Coast Range, lying many miles along the Pacific. It produces large quantities of lumber, butter, fish, and some live stock, which are sent away by small steamers. It has dairy and meadow land equal to any in the world. Its streams abound in excellent fish. Its supply of lumber is practically inexhaustible. Grain and fruit can be raised in perfection. The climate, though wet in winter, is mild, and in summer is like an Eden. The county is sparsely settled, but prosperous. Its towns are out of debt and jogging along without having felt the hard times much. The comparatively few people there are as a rule better off and more independent than those who have a railroad in sight and a big city within reach."

"Much of Tillamook is rough and not to be cleared with profit, but there is room there yet, before its splendid capacities are all tested, for thousands more families. The man with a little means, who wishes to work himself out a quiet, comfortable home, can find few better places to select from than Tillamook county."

We appreciate the kindly mention of this place, but there is a slight misapprehension in the article. A railroad could not retard Tillamook's progress as we have water facilities for transportation. Besides a railroad would not lessen the price of our butter, beef, lumber and fish. Railroads can almost kill some towns, but they can't hurt Tillamook. They can't fix their monopoly rates here.

As to the statement "that much of Tillamook is too rough to be cleared with profit," we say it will be cleared with profit when the lumber market gets in a better state.

We have plenty of good clear land here, more that can be easily

cleared, and this county prospers in spite of the fact that it hasn't a railroad yet.

HIGH TAXES.

We think our taxes are extremely high and grumble sometimes, but the following which we clip from the Grant's Pass Courier, of Josephine county is quite consoling: "The Corvallis Times is grumbling because Benton county is \$12,000 in debt and the levy in that town for state, county, school and city aggregates 24 mills. Bro. Johnson you don't know how well your taxpayers are off. Benton county has over \$5,000,000 assessable property; it has a fine \$100,000 court house and thousands of dollars invested in county roads and bridges. We of Josephine have an assessed valuation of \$1,200,000. Our county debt is \$72,000. Our levy in Grants Pass is 45½ mills and still no cry escapes our lips."

VARIED TASTES.

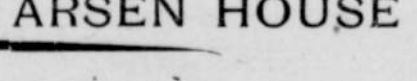
