Circuit Court.

Court convened Monday, Judge H. H. Hewitt presiding.
Among the Tillamook lawyers represented are: I. T. Maulsby, W. L. Brooks, A. W. Severance, E. E. Selph, W. J. May, Claude Thayer and T. B. Handley.

Following is a list of the grand jurors: Mr. Isaacs, Peter Byrom, W. G. Chance, Jonas Olsen, G. E. Mizner, T. J. Bowles, W. H. Eason.

The case of John Paquet against W. J. May was decided in favor of the plaintiff. In this case Mr. May held a tax title on Mr. Paquet's land, but owing to irregularities in the records of the sheriff's office (during Frank Harris' term) the tax title was set aside.

The suit of M. B. Pettes against J. C. Comer and the Bay City Co-operative Co., was decided in favor of plaintiff.

In the case of F. R. Beals vs W. W. Quick, to collect \$60, and \$56 attorney's fees and other costs, judgment was given in favor of plaintiff, and an order made to sell defendant's interest in the James Quick estate.

Flora Blumenthal vs Ann Malaney, et al, judgment for plain tiff for \$300.

The suit of Baxter's against Tillamook county was decided in favor of the latter, and Baxter will take an appeal to the Supreme court. It is understood the Little Nastucca settlers will have free use of the road in the meantime.

The grand jury has returned indictments against Ben Haunhurst and Mrs. W. H. Griffith for adultery, and against C. W. Smith for assault and battery. Mr. Smith has pleaded guilty and will be fined this morning. This is the case of assault on Mr. Bewley.

Several small civil suits have been settled, and others of little importance are in progress. It is thought court will last a little longer than this week. A detailed report will be given next week.

Special Evangelic Services.

Rev. E. A. Holdridge and Mr. Frank Dickson the well known "Pacific Coast Evangelists," whose work in Astoria last spring was said by the press of that city to have caused the greatest religious awakening ever known there, are here.

They arrived in town last Saturday and commenced their work with a preaching service in May's Academy Building. Since that time they have been preaching and singing nightly at assembly hall to constantly increasing audiences. They announce that they are not travelling in the interests of any particular church and are not supported by any church board or private individuals, but aim to present the truths upon which all Christians unite and to strengthen and help the work of all evangelical churches.

Everybody is cordially invited to hear them present the gospel in song and sermon. The meetings will be in assembly hall every evening at 8 o'clock and on Saturday evening they will have a "social religious hour" the exercises differing altogether from those of other evenings, and including a recitation by Mr. Holdridge's daughter, the presentation of a souvenir to each one in the audience and some appropriate solo and chorus singing.

On Sunday meetings will be held as follows: 7 A. M. at the evangelist's headquarters two doors east of the HEADLIGHT office, morning prayer and praise service. 11 A. M. the evangelists will conduct a union service in the Christian church. 2 P. M. children's meeting in the Methodist church, where evangelist Holdridge will tell the story of "Jane and the Pankin seeds." 3:30 P. M. in the Methodist church, grand rally of men this meeting is for men only, special music, and an address to business men by a business man. 8 P. M. in assembly hall union evangelistic revival rally.

The meetings will continue through all of next week, services being held every night and every afternoon, (except Monday).
