Clark, of the North Yamhill Record, who is also of the same belief, are likely to make a lively campaign in Yamhill county.

Burned to Death.

N. A. Eberman was burned to death at his home in Sesside April 19. Mr. Eberman, who has been paralyzed for several years past, was left alone while the other members of the family attended the evening church service. About 8:30 P. M. flames were seen bursting from the Eberman residence. As the crowd watched the burning building, the body of the old gentleman could be seen in the center of the ruins. It was partially out of bed, and the old man had evidently made a heroic effort to escape. With his feet resting on the floor and his body leaning against the bed, he was literally roasted until scarcely a vestige of him remained.
The origin of the fire is unknown but it is thought to have been caused by the explosion of an oil lamp. The loss will amount to \$1000, and there is no insurance.

Mr. Eberman was born in Henry county, Tennessee, 74 years ago, and came to Oregon in 1843, locating near Skipanon. Shortly afterward he married a daughter of the Hon. Wm. Holson, by whom he had 15 children, 11 of whom survive him. He was a veteran of the Cayuse war.—Oregonian.
