Letter from Meyer's.
We are requested to print the following:
To the Public: Salem, Oregon, May 18, 1896.
I have received many letters since my congressional nomination as to my position on the political questions of the present day. My impression is, that the first and paramount question to be considered is the "financial question," and I believe there should be no doubt expressed to the voters on this, no "straddle," but an absolute position on one side or the other.
When a majority of the voters entertain certain views, they are certainly entitled to a representative to express their views in the representative part of the government.
First: On the "financial question" I am in favor of the free and unlimited coinage of gold and silver, independent of any foreign power, into standard money, at the ratio of 16 to 1, and upon terms of exact equality, as they existed prior to 1873; the silver to be a full legal tender, equal with gold for all debts and dues, public and private; and I am opposed to any discrimination by the government against either gold, silver or currency of the country, and that all money shall be equal at all times.
Second: I believe that the "tariff question" should be considered as a business proposition, and as we deal with it locally in every day life, and there is no question but we receive a benefit by the proper kind of tariff outside of the government tax, but there certainly should at all times be conditions that will protect the producer to the fullest extent, as it does the manufacturer and business man; and this is the kind of tariff I want—equality to all, discrimination to none.
Third: That it is important that the best and most economical transportation be had for the producer to the market is beyond dispute.

Nothing will afford this better than "Gold waterways" for free transportation. Every harbor that will admit of a benefit should be improved, and especially should the completion of "Columbia Bay, Siuslaw, Yaquina and Tillamook" not be delayed longer for the growing commerce of Western Oregon. Cobscook Bay gives to the State of Southern Oregon competition, and a market for their fruit, timber and coal. The quality of the fruit and coal cannot be excelled in the state, and why should it be subjected to transportation rates at present, destroying the value of production?
Siuslaw will add thousands of dollars to the wealth by the valuable timber that is complete to seek a market at this day, and create a field for investment, and work for the laborer in the forests.
Yaquina, already connected by rail with the timber belt of the Cascade mountains and the Willamette valley, has made a market for its products. All times markets have been better, and producers have secured a price in advance of the markets on account of these government aids. This is certainly a test of what improvement will do.
The Willamette river must be improved into the city of Portland to the head of navigation at Eugene, with free lockage at Oregon City sufficient to maintain boats during the entire year. There is at all times water enough if properly managed to justify this course by the government. No estimate could be made of the interests of the Willamette valley by this date for the past twenty-five years, and I might as well say so important a waterway is neglected.
Fourth: I am opposed to continual change in the legislation of our country, and I am the opinion that we have more legislation than is necessary for prosperity and successful business.
Fifth: I am opposed to the "funding" of the Central Pacific railroad.
Sixth: There is no doubt that all publications are in excess of all other prices, and they therefore should be reduced without delay, to bring a growing evil on all systems of government.
Voters, consider your own situation—the creditor will continue to knock at your door until something of a permanent relief can reach your labor. Who of you have any assurance the profits can come to you until legislation is your interests? Stop, and meditate upon the important questions.
The foregoing is a statement of my personal views on these, the leading questions of the present campaign. I regret that I cannot answer you personally, and take this method of presenting my views to you.

Hayden vs. Carson.
Ed. HEADLIGHT.—Wishing to see in play, I would call your attention to the following which appeared in the Daily Statesman, the leading paper of Oregon, April 21st and 22nd 1893; in regard to J. A. Carson:
On March 27th, 1892, Andrew E. Harvey, a Salton campaigner, and soon thereafter J. Simon was by County Judge Davidson appointed administrator of the estate. Mr. Simon having bought some accounts against the estate to enable him to appoint. The estate consisted of nearly \$400 in cash in an Illinois bank. The attorney for Mr. Simon was John Carson, a Salton, who has rendered a bill for his services to which the heirs object, being represented by attorneys D. Arcey & Bingham and Seth K. Barmmer. This bill is itemized, and is for \$60,000, which Mr. Carson agrees to take \$20,000. Mr. Simon as administrator has also a claim for \$20,000 against the estate for his services. The arguments of the attorneys who object to Mr. Carson's bill were heard by County Judge Hubbard Tuesday. The reporter thinks the case is of sufficient importance to justify the perusal by the public of the itemized bill of Mr. Carson, in brief as follows: Retainer fee \$50, conference with Judge Davidson \$10, petition for probate of will \$10, payment of \$10,000 to Carson & Bingham \$10,000, fee on conference with creditors \$20, fee on drawing petition by creditors for administration \$10, in regard to administrator's \$5000 bond drawing bond, etc., \$10, long conference with Ben Harvey in regard to removing administrator \$10, fee on appointment of appraisers \$10, to bank to inspect property, etc., \$5, conference with administrator, etc., \$5, fee for preparing inventory, etc., \$10, fee for attending on widow \$10, conference with administrator \$10, etc., \$25, retainer fee to take \$20,000, \$10, making annual account, etc., \$25, conference with administrator and widow \$10, drawing affidavits \$10, drawing answer for administrator \$10, fee for attending court, etc., \$10, for conference with administrator \$5, fee for drawing petition for burial lot, monument, etc., \$10, conference with M. A. Cook, etc., \$10, fee also for attending court, etc., \$30, drawing seven affidavits \$10, drawing copy of will, etc., \$5, fee to administrator to pay over money \$10, attorney upon \$10, drawing final account, \$100, construction will \$15.
LIED ABOUT IT.—Attorney John A. Carson reported as charging the Statesman with having named his bill in the Harvey estate as any and unreasonably. Somebody had lied about this. The Statesman did not say anything of the kind. It simply reported the news of the day, giving the itemized bill, which was a matter of public record and which was the duty of all real newspaper to publish. The Statesman has no fight on Mr. Carson, or anyone else. It simply says papers. County Judge Hubbard, however, cut down this bill against the estate to \$120, which with the \$20 to the administrator makes \$140 for settling up an estate of \$400,000, all of which was cash.
I wish also to call your attention to the fact that Mr. Dalrymple made Wilson of the Statesman in regard to Dalrymple's selling of Hayden. Wilson was called upon to produce alleged proofs, but after humming and hawing awhile, acknowledged that he had none, and that another man wrote the article he published. There is no truth in the selling out story ever.
