The Republican Senators who framed the tariff bill have denounced as false the published charges that the Sugar Trust controlled the formation of the schedules of the tariff bill relating to its product, and have challenged a public investigation of the statement.

Business reports from all parts of the country continue to be encouraging. Dun's Review of last week shows that the quantity of business handled through the country is nearly as great as in the years of greatest prosperity, the May business exceeding that of April, which was within 10 per cent of the largest on record. While the margins of profit are smaller than heretofore, the amount of business handled is larger and with gratifying prospects for the future.

The Southern wing of the protection party in the Senate received another acquisition to its ranks this week in the transfer of Hon. J. C. McLaurin from the House to the Senate, to succeed the late Senator Earle, of South Carolina. Mr. McLaurin's speeches in the House during the consideration of the Dingley bill were strongly in favor of protection and against the Democratic theory of free raw material. There were already five Southern protectionists in the Senate and thirty in the House.

The occurrence of Wednesday night of last week was deplorable in every respect. It is not to the credit of any city to have such things occur in it. But there is probably only one way to avoid them, and that is not to give occasion for them. Tillamook is not disrespectful to ministers of the Gospel, Rev. Mr. Corner, of the M. E. Church, Rev. Mr. Dallas of the Christian Church, and other ministers reside here, and have the respect of everybody. Their meetings may occasionally be disturbed by thoughtless youngsters, but they treat "the boys" kindly and with consideration, and get along with them swimmingly. Not a boy in Tillamook has ever offered them either insult or indignity. If that Monday night meeting "for women only" had not been held, and if the boys had not been told that they were a lot of "young hoodlums," whom it was the special mission of the preacher to "learn how to behave in church," there would have been no trouble. The public in general does not excuse either the boys or the preacher for the parts which both took in the matter.

The right of every individual to have and be governed by his own opinions in all matters of religious belief is so well recognized by and guaranteed in our constitution that no room should be left for cavil or dispute; but it seems that such is not the case.

Every day men are held up to the execration of the faithful because they find it impossible to twist their minds into an endorsement of the creeds of others, and an advocacy of their opinions.

It is impossible for any man to thoroughly control his opinions. Prenatal influences, early education, environment, observation and study, all tend to making what a man believes and what he does not believe, and as all these circumstances differ with different individuals, so there must of necessity be a variety of beliefs. The man who rails at his neighbor because he differs from him in opinion simply shows his own narrowness, ignorance and egotism. Broad minded men,—gentlemen, rarely fall out with each other over differences of opinion on religion and other matters.

Attorney General McKenna is going to try his hand at enforcing the Sherman anti-trust law, which the Cleveland administration declared could not be enforced. He has directed that suit be entered in the U. S. Circuit Court against the Trader's Live Stock Exchange, of Kansas City, for violation of the anti-trust law by boycotting commission merchants who sold stock to those who did not belong to the exchange.—Ex.
