

Odds and Ends.

It is estimated that the wheat, hops and wool of this year's crop will produce a return to Oregon of \$14,000,000. Some place the figures much higher.

The number of sheep and cattle assessed in Malheur county for 1898 is as follows: Cattle, 25,122 head; sheep, 91,331; horses, 10,098.

The Oregonian is authority for the statement that servant girls in the metropolis are very scarce. Since the Chinese exclusion act went into force Chinese domestics have not been obtainable, and the old supply is running short.

A Kansas preacher engaged himself to 13 girls and one of them found it out, and, of course, the other 12 found it out then, too, and when cornered by the friends of the girls he could not tell to save his life how he came to do such a thing.—Ex.

Dwellings are scarce at Baker City. Any five-room house within reasonable distance of the business center commands a rental of from \$12 to \$15 per month. Scores of houses cost from \$450 to \$600 to build are rented for from \$10 to \$12.

Mrs. George W. Daley, sr., is engineer in her husband's saw mill at Round Top, Jackson county. She does her own firing, measures the logs as they are rolled upon the carriage, and superintends the sorting of the lumber. Mr. Daley is head sawyer at the mill.

It has been the rule to wait till prunes dropped on the ground before gathering them for the evaporator, but the weather has been so dry up to this week that the prunes do not drop, and hand picking has been adopted. The fruit was actually drying on the trees.

There has been a great demand for labor in Josephine county, throughout all the summer. This demand has been mainly on account of the many new ditches constructed, or lengthened. And it still continues. There is no scarcity of work in Southern Oregon for the horny handed sons of toil, and they have considerable numbers from the Willamette valley, and as far south as Sacramento.—Oregon Mining Journal.

Nobody has heard of anyone kissing Sampson as yet. Hobson and Schley have monopolized the kisses. But when Dewey comes home he is likely to be kissed to death. Sampson may be short on kisses but he is long on cash. Although he took no active part in the destruction of Cervera's ship, he will receive the lion's share of the prize money from the government. Saturday night last it was estimated that little more than half the grain crop of Union county for 1898 had been threshed. It will be late in October before the entire crop is threshed, and few farmers may not get through before the 1st of November. While the acreage is greater this year than last, the output will be about the same, spring wheat being lighter. The quality of the wheat, however, this year is much better than last, the grain being good dry and hard. Last year, much of the wheat went 56 pounds to the bushel, while those best posted say that it will go 61 1/2 pounds this year. The estimate for the county this year is 1,500,000 bushels of wheat, 400,000 bushels of barley and 200,000 bushels of oats.
