Some war department officials are reported to have admitted that the dispatches of General Otis that have been withheld indicate that much more fighting is to be expected before the Filipino insurgents will accept the American terms of peace. The persistence and tenacity of purpose of the rebels has proved a great surprise to both the administration and the department. Many of the officials believe that the plan of the rebels was to make a simultaneous attack upon Manila and on General MacArthur's force near San Fernando, but no disastrous result of such an attack is expected.

We think a number of cyclists are talking through their hat when they speak as though it would take but an insignificant sum to construct a bicycle path between Tillamook and Bay City. In all probability they have had no experience or insight how a path should be built, especially in this county where the rainfall is about 120 inches a year. Several things are necessary to make a path that will be substantial. First, a good grade with the drainage properly attended to. Second, a foundation of rock—and plenty of it—then several inches of coarse gravel well rolled down, and over this several inches of fine gravel. Figure it out what this will cost to construct per mile and then one can get at an approximate estimate of the cost of constructing a bicycle path to Bay City.

The Astoria Herald, in a two column article on advertising the resources of that city, says: "During the past three years there has been contributed by Astoria people to outside publications over \$10,000 for advertising Astoria. What good has it accomplished? It has not brought one penny of capital to Astoria. It has not brought one manufacturing institution to Clatsop county. It has not brought one farmer to buy our lands; it

has, however, brought tramps, hoboes and grafters to the city. . . . The only way to advertise a city is through the home newspaper. And a home newspaper must show in its advertising columns the appearance of prosperity." This is why we are putting several hundred dollars into a special edition to advertise Tillamook county and city, for with a judicious distribution of several thousand copies of the home newspaper, gotten up to interest settlers with means, will do more good than paying advertising factors to distribute a lot of fictitious trash which induce tramps and hoboes to infest the country.

We hardly know whether Captain J. J. Dawson, Tillamook's weather prophet, should be run out of the country or the citizens kindly invited to pass a vote of thanks to him. However, we cannot recommend the former course for his predictions have proved too tarnished correct, so the latter must be the correct thing. The eclipse on the 7th inst. having brought, as he gave warning that it would, light rain and frosts, injuring the apple trees in some parts of the county, must have emboldened him to make a similar prediction. Here it is in a nutshell: "It will be well for the people to take warning on the night of the 22nd June, as the eclipse takes place between three and six a. m. the 25rd, and cover their tomato, cucumber and other plants that can be froze; early hay makers take notice and govern yourselves accordingly, as there is a possible show for some heavy rain with it." Gee wiz, Dawson, have you formed a trust or a combine at your station with the elements to make Tillamookers a little more amphibious? But predict what he may, we defy Prophet Dawson being able to manufacture anything like a cyclone to knock the very stuff out of this city as they have been doing to those in the east.

In his remarks at the commencement exercises at St. Alphonsus academy last week, the Rev. Father Schell made one remark which greatly concerns the success of all private and public schools—that of having good teachers. There is this trouble with our public schools, we have so many young and inexperienced teachers, consequently pupils do not advance in their studies as they would otherwise with experienced teachers. The reason of this is plain, for school districts do not pay enough salary to warrant them remaining teachers; hence they make the profession a stepping stone until they can find employment which will remunerate them better. We advocate paying teachers good salaries, who have experience to commend them. If this was the aim of most school directors they would be living more up to the spirit of our public school system. Most of the time they can keep the school running with the money at their disposal, and, invariably, they elongate it by employing an inexperienced teacher at a small salary. We may be wrong in our ideas, but we would rather see pupils put under the instruction of an experienced teacher for three months rather than four months under one inexperienced.

The second annual commencement at St. Alphonsus Academy on Thursday brought together quite a large audience. The programme, as published in our last issue, was nicely gone through, showing that the pupils had been well trained; in fact, from the opening chorus to the farewell, piece after piece followed in rapid succession with mechanical precision, which drew forth the plaudits of the audience. All the pupils acquitted themselves well, carrying out their parts without the least embarrassment. Miss Belle May deserves praise for her recitation. Father J. Schell distributed

the awards as follows: In the Academic course, gold medal, crown and diploma, Miss Belle May; in the stenographic course, diploma, Miss Clara Delsman; department, premiums, the Misses Belle May, Clara Delsman and Flora Perkins; highest average in mathematics, premium, Miss Belle May; prize essay, premium merited by the Misses Teresa Cronin and Nettie McKinley, which was drawn by the latter; highest average in B senior, premium, Miss Flora Perkins; highest average in C junior, premium, Master Henry Sanders; highest average in grammar grade A, premium, Miss Helen Anderson; department in grammar grade, premium, Master Frank Sanders; proficiency in music, premiums, Misses Nevada Grayson, Helen Anderson, Masters Charles May and Thane Orchard. It is only right we should bestow praise where praise belongs. The Sisters, in conducting this excellent institution of learnings, deserve much credit for the progress the pupils have made in their studies, which show they are thorough and practical in their teaching.

The question of contention on Monday before the city council—that of using profane language on the streets—is a matter which needs comment, not that this city is one wit worse than other cities. The fact is there is too much levity allowed on the Pacific Coast to those who use profane and even disgusting language, so much so that men have become accustomed to it that they pour forth vile epithets as though it were the choicest of language, hardly realizing to what extent they have allowed themselves to acquire the vulgar habit. Even some professing Christian are not exempt from criticism in this particular and would do well to remember, "Thou shalt not swear," and the Divine warning of taking God's name in vain. Because men have become profane chronic swearers is one reason why something should be done to check the disgusting habit. We would rather see a man beastly drunk on the street than hear a man using low, filthy language, for the latter is the most contemptible, surely the English language contains enough strong words to make arguments persuasive without a conglomeration of all the filthy words which some men cannot open their lips without uttering. Like every bad habit, swearing grows on a man after using the big d several times. We have no compunction in saying that the man who uses profane and disgusting language disgraces civilization and lowers the moral tone of any community. It may be impossible to cure those who have long indulged in it, but for the sake of refinement, culture and purer conversation, it is not time something was done to protect the rising generation from acquiring the pernicious habit? Men would become better citizens, husbands, fathers, and not so quarrelsome, if they would put the breaks on when they feel like cursing and swearing. We hope the city dads will not acquiesce any longer with that ordinance, for the gentleman who uses gentlemanly language need never fear being arrested for using proper language. These remarks may touch some people in tender spots, but until they can convince us that obscene language is elevating and refining, they must not take exceptions to what we have stated.

The Tillamook band will be in attendance all day.

The morning parade will consist of the band, liberty car, G.A.R., Dewey's flagship Olympia, Tillamook hose company, grand display by the merchants, carriages occupied by the Mayor and City Council and the orator of the day, prominent citizens, etc.

City Council.

The city council met on Monday evening, with Councilmen J. E. Tuttle (in the chair), A. J. Cohn and L. Olsen present, and the discussion of a proposed ordinance to prohibit the use of profane and obscene language took up the time of the councilmen. Councilman Tuttle was the first to object to the ordinance, but after the matter was argued from several points changed his opinion and was in favor of it passing. Councilman Cohn thought the city should have an ordinance to prohibit obscene language. He thought, however, the ordinance should be modified to show there was evil intent by the person using profane language, and tenaciously adhered to that through the entire discussion. Councilman Olson at first thought the ordinance was rather strict in its wording and favored having it modified, but eventually came to the conclusion that it would be well to pass the ordinance, and if it did not suit amend it at some future occasion. A dead lock occurred, and the ordinance was left over until the next meeting, which is as follows:

Sec. 1. It shall be unlawful for any person or persons to use profane or obscene language on any street, alley or highway, or in any public place or assemblage, within the corporate limits of Tillamook City, in Tillamook County, Oregon.

Sec. 2. Profane language is hereby defined to be, the taking of the name of God in vain, or any irreverent or disrespectful use of the name of God, or of that of either member of the Holy Trinity; and obscene language is hereby defined to be, any language that is foul, or that tends to deprave or corrupt the morals.

Sec. 3. Any person or persons who shall violate the provisions of section one of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished by a fine of not less than one dollar nor more than ten dollars, and in default of the payment of such fine shall be imprisoned in the jail of Tillamook City for such a period as will liquidate such fine at the rate of two dollars per day.

Mr. H. G. Davis addressed the council. He claimed that the property he had bought next to the school house included the street on the north side, and he was wanting the council to pay him for that

provided he made a deed of it to the city. It was pointed out that the side walk along the property, which was laid by the city, had never been paid for. The matter was left to the city attorney to investigate.
