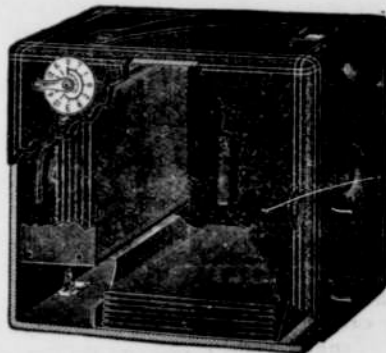

From Indiana he went to Kansas, and from there to California in 1872. Three years later he came to Tillamook county and took up government land. He was married four times and raised ten children, four of whom are now living. He was at one time a county assessor in Kansas and was agent in Tillamook county for the Home Mutual Insurance company. The deceased was a member of the I.O.O.F. and also a member of the Christian Church, where the funeral services were conducted on Wednesday by Rev. H. B. Morgan, and the remains buried in the I.O.O.F. cemetery, a delegation from that order attending the funeral. The deceased was instrumental in getting the road built from South Prairie to Netarts.

Here's a Chance for Tillamook.

Here is something which should interest dairymen and the creamery companies of Tillamook county. A news paragraph in the Oregonian says: "A lot of choice creamery butter is now being put up by one of the dairies in this city for shipment to Manila. It is packed in large jelly glasses, having glass covers, which will be hermetically sealed, and the whole packed in salt. Inside the cover of each is the card of the manufacturer, Portland Or., and a guarantee that the contents are of the finest quality, and contain no chemicals or impurities of any nature. A small shipment of this butter, made some time ago, went off like hot cakes in Manila in competition with the Danish butter heretofore used there, which is supposed to be the finest made. Butter is now produced in Oregon which cannot be surpassed by any Dane or Swiss on earth, and before long there will be a market in the Philippines for a large quantity of this and other products of Oregon." Now if a Portland creamery can put up and ship butter for the Philippines it cannot discount Tillamook creameries if this county is given an opportunity to do the same instead of shipping butter from Tillamook this winter, with irregular shipping facilities, would it not be well for the creamery companies of this county to make some investigations with a view to ascertaining if it would not be more profitable to compete in this trade than be subject to the loss they have to stand in winter time through the delay in getting their product to the Portland market? We believe it would enrich Tillamook dairymen thousands of dollars this winter if they can pack their butter in this way, not only in transportation, but in the top prices they will always be able to command here in Tillamook. This is a matter which requires immediate attention, for every person with business instinct will readily see that, taking every thing into consideration, is something which this county is wanting, until facilities are secured for sending Tillamook butter daily to market.

Let Tillamook Exhibit.

The Port of Tillamook Commission sent out this week the following circular letter to a number of farmers: Offices of the Port of Tillamook Commission.

Tillamook, Oregon, Aug. 14th, 1899.
DEAR SIR,—There is to be an attempt made to send an exhibit to the State Fair from this county this year. We want to make as good a showing as possible of the grasses, woods, honey and other products of the county. The collection will be made here and will then be sent to Salem and afterwards possibly to the Portland Exposition. Every thing should be in this city by the 1st of September.

Will you kindly assist by letting all the farmers know of this and ask them to send whatever they can that is worthy of exhibition.

Wool should be sewed onto a card in bunches and the bunches labeled with the kind of wool and the number of days growth, that is the length of time since the wool was sheared.

Honey should consist of a small box or two from each man with his name. Grasses should be tied up in sheaves with the owner's name.

We think that in most cases the mail carriers should be willing to deliver these packages at Tillamook City as a matter of public benefit. Your kind assistance in the matter will be appreciated.

The officers of the State Agricultural College will hold a Farmers' Institute in Tillamook City on First Wednesday after the 4th Monday in August, when two days will be devoted to discussing papers on farming and dairying. See further particulars of this interesting event in the local papers.
