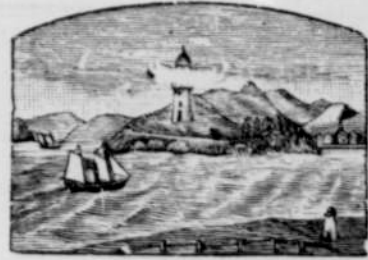

The fourteenth annual convention of the Oregon State Sunday School Association will be held at Albany on October 26-28. A splendid program is being carefully prepared, helpful speakers will be provided, and every worker benefited. The importance of this meeting, the low railroad fares, the warm welcome assured the delegates, should insure a large attendance, and Sunday school workers bearing proper credentials will receive free entertainment. The secretary, Mr. A. A. Morse, asks that pastors and superintendents set apart Sunday, Oct. 22nd, as a day of special prayer for the convention.
A pleasant time was participated in at the residence of Mr. H. E. Weston, it being the occasion of his mother's 80th birthday, and to commemorate it some twenty-two relatives and friends assembled on Saturday evening. They had provided themselves with an abundance of good things, when a most enjoyable social time ensued until a late hour. Before they left they expressed themselves well pleased, congratulating Mrs. Weston and wishing her many happy returns of the day. Mrs. Weston is well known in this vicinity, being highly respected by all. She is remarkably well and looks much younger than she is.
The death of ex-Governor W. W. Thayer was a great surprise to the citizens of this city on Sunday. Tillamookers had a great respect for the venerable gentleman and ex-governor of Oregon, and it was with the profoundest regret that they heard of his death. It will be remembered that he visited in this city last July, delivering the oration at the celebration on the Fourth. His honorable trait of character won for him a name in the history of Oregon which young men might with advantage emulate. He was a conscientious governor and jurist, and by his death Oregon has lost another of her honorable and distinguished citizens.
All the parties who recently filed on timber lands have been notified by the attorneys for the Northern Pacific Railroad that their claims will be contested. One of their reasons for so doing is that the persons making the timber claims were not citizens, native or naturalized, of the United States. Another reason is that the entrymen were not citizens or residence of any particular place, but constituted, in a large measure at least, what are generally known as 'floaters' and 'itinerants,' which facts are of public notoriety, and generally known and understood; and that they were picked up and collected in the city of Portland and other places, in large numbers, and taken to the land office. Now if a newspaper had to start in and call a lot of respectable citizen aliens, floaters and itinerants it would expect to have a big lot of libel suits on hand, but why should attorneys or railroad corporations have more levity in sending out libelous matter than newspapers?

Is the Southern Pacific railroad trying to get a grip upon Tillamook county? It was Mr. A. B. Hammond's agents, of the Astoria & Columbia Railroad, who placed the scrip upon 37,000 acres of timber lands recently, and as that railroad is without a doubt the property and Mr. Hammond is the tool of the Southern Pacific, there must be some object in the railroad getting control of large tracts of timber lands in this county. If our supposition is correct, Tillamookers ought to move heaven and earth to have the bays and rivers improved for navigation before the county is Californianized by a monopolistic, blood-sucking railroad. Give Tillamook county deeper channels across the bars and in the bays and rivers, so that navigation for larger steamers can be thoroughly relied upon, then, and not till then in our judgment, should Tillamookers advocate the construction of a railroad into this county. By making haste too fast it may be that a railroad would have the drop on the county, like the Southern Pacific in California, but with steamship competition, that would keep a railroad from exacting exorbitant charges.
Judge Sappington held probate court on Wednesday of this week, for the purpose of hearing the evidence upon the petition of the bondsmen of C. G. Cutting, former guardian of the minor children of Brady Wilson, deceased. Cutting left the state nearly two years ago, and has failed to make proper accounting of his trust as guardian. He is the step-father of the Wilson children, and the bondsmen claim that a portion of the children's estate has been used for their support and maintenance, and that therefore Cutting should receive credit for such expenditure in his accounts. The evidence introduced on behalf of the bondsmen showed that Cutting had no property or income of any consequence except what belonged to his wards, and that after he received their funds he supported them well. Mrs. Cutting, who has recently been appointed guardian of the children, avers that no part of the children's funds has been used for their benefit, and therefore she seeks to fix a liability upon the bondsmen for the whole sum that came into Cutting's hands. From a paper filed in the case by the bondsmen it appears they believe that there is a fraudulent attempt being made to enrich the Cutting family at their expense. The bondsmen are well known and substantial citizens of the south end of the county. The court took the matter under advisement.
If another illustration is needed to show the necessity of having the government improvements completed at once in Tillamook bay and at the bar, one presented itself last week. Tillamook bar had been shoaling up to such an extent that when soundings were taken Thursday only twelve feet of water at high tide was found. Now what is the result of this upon the commerce and industries of Tillamook county? Here it is in a nutshell. Nine steamers and schooners were

bar bound on Thursday, one of which, the steamer Luella, had been unable to cross out for three weeks. All these vessels were carrying Tillamook products to market—butter, cheese, canned and barreled salmon, cranberries, and, not least by any means, lumber. To those who make the assertion that the commerce of Tillamook do not warrant the expenditure of government money for improvements look upon the matter in the wrong light, for the immense belts of timber in this county warrant it. What improvements the government engineers have in hand to complete their present plan, it should be finished as soon as possible, although this cannot be done until congress makes another appropriation. Tillamookers are expansionists, not of the calamity howling class, but expansionists who want to ship their products to markets with an assurance that it will get there in reasonable time.
