From the Ocean Wave of Oct. 19: This morning, early, Sam Hushbeck, who carries the mail between Woods and Hebo, had a miraculous escape from drowning. In crossing the river at the town, his small boat became entangled with a log and the ferry cable and was overturned. As it so happened he was thrown against the ferry cable which was near the top of the water. He plunged himself ashore on the line from near the center of the river. He was full of water and exhausted upon reaching the bank. After resting he secured the mail and went on his way. The boat floated on towards the bay and at last accounts has not been picked up.
The chief engineers for river and harbor improvements in Oregon and Washington have submitted their estimates for the coming fiscal year, and the sum of \$27,000 is mentioned for Tillamook bay. As far as Tillamookers and the transportation companies are concerned this appropriation cannot be made too soon and the engineer can be none too quick in completing the present projected improvements. Whether this amount will be enough to carry out the ideas of the engineers and it will accomplish their intentions, it remains to be seen. The commerce of Tillamook county, also its development, for the next few years depends greatly upon the success of the government improvements in Tillamook bay and Hoquarton slough.
