The building committee of the Presbyterian church received on Monday \$800 from the board of erection and \$100 from Mr. W. Ladd, of Portland, towards the new church building in this city, which is to be used for public worship for the first time next Sunday, but which will not be dedicated until the spring.

When it comes to profitable farming, dairying is the industry which pays, as is illustrated in Tillamook county compared with the farmers in the wheat districts. Dairymen in this county realize over twenty cents per pound for their butter fat, and no matter how many cows they may keep and milk, or let them double their product for that matter, there is always a ready market for their milk at the cheese factories or creameries, and will continue to be. Thus the dairymen in this county have no fear of over production or that the market price of milk will fluctuate like the wheat market. The dairymen in this county have a bright prospect before them, with plenty of room for expansion, and as all the creameries and cheese factories are all wanting more milk, this presents a good opportunity for the enterprising dairymen to increase their dairy herds as well as their banking accounts.
The Port of Tillamook Commission meet on Monday afternoon, and in the absence of President Olsen, Vice-President A. J. Cohn presided, when the other members of the commission present were Messrs. P. W. Todd, D. T. Edmunds and P. McIntosh and Secretary C. Thayer. The commission decided to levy a tax of one mill. After discussing the work to be done for the improvement of Hoquartion slough, the commission came to the conclusion that the slough should be made straight, and instructed the secretary to draw up a resolution to that effect and forward it to Captain W. W. Harts, the government engineer. This is a good move on the part of the commission, and is very essential for the improvement in the shipping facilities of this city. As this somewhat accords with Captain

Hart's ideas when he made an inspection of the slough, it is more than probable that he will recommend this, commencing the work at this city and then work down to the bay.
Here is a political tip the Headlight offers gratis, and, not to mince matters, must be strictly adhered to: The republican delegation from this county should be instructed to vote for Mr. Tongue's re-nomination. This is good horse sense and good politics, which the delegates to be sent to the county convention will do well not to forget. It may be questioned why we have taken our coat and tucked up our sleeves in Mr. Tongue's behalf. It's told in a nutshell. The congressman who is interested in Tillamook county, sees the drawbacks to our industrial development on account of shallow bars, and then labors for the removal of these obstructions by securing government appropriations is worthy of the support of every dairyman, manufacturer and producer in this county, so we loyally give Mr. Tongue our support because he has proved himself to be a faithful friend of Tillamook county. It was through Mr. Tongue's influence that this county received \$25,000 in the last government appropriation, and it will be through his influence that the proposed improvement to Tillamook bar is carried through and the appropriation secured. Tillamook has been "bottled up" long enough, and now we have a friend at court working to relieve the situation, is it not good horse sense and good politics for citizens of this county to strive all they can to keep Mr. Tongue in congress?

Dehorning Cattle.
As a number of my neighbors and others are having their cattle dehorned, I wish to impress upon them the necessity of preventing the growth of horns in the future, so they will not have to do a similar job again by and bye, so will again give the formula for dehorning calves.
When the calf is about ten days old, clip the hair off the embryo horn, wet the spot slightly, and rub with caustic potash. A piece one inch long will dehorn a half dozen, if they are ready at one time. If you have but one to operate on, take as small a bit as you can hold. I have successfully dehorned them when over three weeks old, but from ten days to two weeks is better. When grown it is hard to tell them from natural polled cattle.
