Mr. B. L. Eddy has been appointed attorney to the board of school commissioners in this county.

Mr. Claude Thayer has secured from Mr. J. J. McCoy booming grounds for logs at the mouth of Doroughty slough.

From the number of letters reaching us there appears to be quite a number of persons wanting to know something about Tillamook, for we answered 23 of these correspondents on Saturday by sending special editions.

Mrs. Jessie S. Vert, worthy grand matron of the Eastern Star, is paying Silver Wave Chapter, No. 18, an official visit, and we are asked to request all members to be in attendance at the regular session next Saturday evening.

Some people think the Headlight is a public benefactor calling attention to the number of quacks, fakirs and schemers who are infesting this county, while a few others think the editor should take back what he said about them. We mention this to show how people look at things and differ in their opinions. In view of this little incident, is it a wonder that an editor cannot be expected to please all the people all the time?

Deputy Grand Master Wagoner is a cracker-jack in presenting the aims and objects of the A.O.U.W. to people, so much so that the number of members in Star Lodge is likely to be duplicated before he leaves. Bro. Wagoner says that the order is so well known that it needs no recommendation, hence those who want life insurance and protection for their wives and families have no difficulty in joining.

Phoebe Alderman has filed suit against A. L. Alderman in the state circuit court at Portland for a divorce and for the custody of their two children. She alleges, in her complaint, that they were married in Tillamook county, January 15, 1865, and that he willfully deserted her in July, 1886. The plaintiff further avers that the defendant struck her in August, 1897, and drew a revolver upon her, and that the last year they were together he failed to provide for her, although able to do so, and she was compelled to work in a hotel in order to obtain her support.

The picture presented by Mrs. Hoxter in this city last week, alas, is no new one. Social purity is a delicate subject to handle in the newspaper, from the pulpit or from the rostrum, but nevertheless it is a matter of so much importance that the very existence of the United States rests upon it. Social purity in the individual means social purity in the home and community, and it is not alone at woman that the finger of scorn can be pointed, for many men who ruin or help to ruin young women would consider it a terrible crime on the part of someone else if they attempted to ruin their own sisters or any of their female relatives.

Messrs. W. J. Wall and Chas. Lamkin, of Hillsboro, were in the city last week. They were here in the interest of the band association, wanting the Tillamook band to affiliate with it. As the association will provide the music for the state fair this year, it has also been decided to take all the bands to the fair free of charge, where the massed bands will occupy the orchestra for two days. As this should cause some interest in making the bands throughout the state proficient, also be the means of creating a pleasant rivalry, no doubt the musical ability at the fair this year will be above the average. We should like to see the Tillamook band reformed, join the association and

take part in the musical performance at the state fair.

We think the intentions of the city council to economize as much as possible is a move in the right direction, and as "economy and retrenchment" was the battle cry upon which the members were elected, let us kindly inform the city dads where they should reconsider a little matter which may cost the city quite a large sum of money. It is evident to everyone that the city cannot have a night watchman and that person be the street commissioner at the same time, the dilapidated condition of some of the cross walks and side walks in the city the past few months proving this, unless the council is prepared to pay a deputy for doing the street commissioner's work. Somehow it don't look exactly right and somewhat askew to notice that the city marshal is receiving salary for the honor of holding down the street commissioner's job. To use a favorite word of Councilman Olsen, don't you think, gentlemen, it would be a good "idea" to reconsider the matter.

A correspondent wishes to know why the Headlight fails to publish the considerations in the real estate transfers. One reason is this: In a number of cases the figures named are not the actual sum paid. For instance, the Astoria Company is paying \$1,000, and more in some cases, for timber claims, but when the deed is recorded the consideration is several hundred dollars less, although it contains sufficient revenue stamps to cover the larger amount, hence the editor does not want to be guilty of misguiding people who have timber lands to sell or become the tool of those who want to keep the price of timber lands down as low as possible for the purpose of gobbling them up themselves. We believe we are correct in making this prediction, that as soon as it is known that the government will improve the bar, the timber lands tributary to Tillamook bay will not be long before they double value. We would advise our correspondent to keep a stiff upper lip and not sell his timber land for a song.

Mr. F. I. McKenna, who was sent out by the Portland Board of Trade to investigate the coal prospects in the Nehalem country, passed through this city on his way home on Friday. Mr. McKenna is well satisfied that the coal is of a fine quality, but is not able at present to determine the thickness of the veins and whether it would pay to work them. However, to ascertain this, he informs us that Portland capital will be used to sink a tunnel, and should the quantity of coal prove to be sufficient, an effort will be made to mine and ship it. He had but little time to speak of his investigation, but from what he saw of the lay of the country thought coal may be found in any of the country between Nehalem and some miles south of this city, with indications also of finding oil, although it may be necessary to go down below sea level to find it. Mr. McKenna thought it would be a good plan to find out what resources were buried in the bowels of the earth in this county, as no one appeared to know, and he suggested boring about one thousand feet, which could be done for about \$2,000.

Mrs. M. E. Hoxter gave an interesting talk on Friday at the United Brethren church on the work being done by the W.C.T.U. and the Refuge home in the city of Portland. One hundred thousand persons in the United States annually descend to a drunkard's grave and this country sacrifices fifty thousand young women every year for bawdy houses and resorts for prostitution. Mrs. Hoxter thought this great sacrifice of humanity to satisfy appetite and passion was a blot upon the United States—and calling itself a Christian nation. No heathen nation could be worse, and she said she felt ashamed of her country when she saw so many victims being thus sacrificed. She stated that it was mostly young girls from the country districts who were led astray and became inmates of houses of prostitution, and sometimes against their own will. She also told of girls being induced to leave their own homes in foreign countries with the promise of good situations and good wages, but when they arrived in this country they were taken to houses of ill repute, locked in rooms and then morally ruined. Mrs. Hoxter showed what was being done to rescue unfortunate women, some of whom were as young as 13 years; also in protecting young girls from the inducements held out by brothel house keepers, who had runners on the trains watching out to betray some innocent young woman into their haunts of vice.

A meeting of the city council was held on Monday evening, with President A. J. Cohn and Councilmen L. Olsen and M. Leach present. The council issued an order for Messrs. Brown, Peckham and Monroe to fix the roads abutting their property the same as other property owners in that vicinity. A good deal of the council's time was taken up in discussing the bad condition of some of the cross and side walks, and the council instructed the street commissioner to notify the property owners to have their side walks fixed where they needed repairing. Mr. J. E. Tuttle was elected councilman in the place of Mr. L. Hiner, whose seat had been declared vacant; and Mr. G. A. Edmunds having resigned as councilman, Mr. S. Broadhead was elected in his place. Mr. W. H. Cooper, representing the water company, was present and asked that the council enter into the con-

tract which it had agreed to at a previous meeting of the council, whereby the water company was to furnish the city with water for municipal purposes at a rental of \$30 per month for a period of three years. The council promised at the first opportunity to see that the pressure came up to the requirements, etc. Bills ordered allowed were C. Miller, \$1.50; A. A. Ford, \$4; T. Coates, \$10; D. C. Pierce, \$4; J. F. Jenkins, salary as marshal, \$39, as street commissioner, \$26. A bill for lumber was laid over, it being stated that the previous city marshal had orders not to order lumber from the Pacific Lumber Co., because it had not fixed the road leading down to the mill to the satisfaction of the council after being paid to do so.
