Several aspirants for municipal honors have already bobbed up, and that to wear the marshal's star appears to be their ambition. Some people expect that the next city election will be a warmly contested affair. Is this because the presidential election was such a one-sided, dead affair they are going to entuse a little life into the city election?
What a great improvement it would be to the business part of the city to have the roads blocked paved. It would not only add to the clean appearance of the city, but it would make them permanent

business streets. With so many nice looking business houses in the city, somehow the mired-up roads do not add to their appearance.
Mr. W. N. Bays brought in 66 head of Angora goats from the valley last week and he sold them at \$5.25 each. Mr. W. S. Cone bought a small band of 40 and took them down to Bay City on Saturday. Mr. Bays brought some goats to the county about ten years ago, when the price for Angoras was \$3 each, and the raisers thought they had made a good thing at that figure. He leaves for the valley this week to bring in another band from there.
We think every sensible person in the city will commend the city dads for instructing the marshal to strictly enforce the law when residences and their occupants are quarantined on account of infectious disease. No doubt it is exceedingly unpleasant to be quarantined, but whatever inconvenience it may entail, it should be cheerfully endured, for the health and the lives of citizens should not be jeopardized by persons carrying infectious diseases. Some people ridicule the idea of quarantine, but this class of people makes it hard for municipal authorities to stamp out infectious diseases.
Now that the election is over let us all make a strong, long and united pull for the improvement of Tillamook bar, so that this county can add to the wealth, commerce and prosperity of the state for the next four years, for this is now the paramount and only issue for Tillamook county, and until the improvement of the bar is sanctioned by the government, no other issue can take its place. We shall not have to wait long, perhaps, as the next river and harbor bill will decide the matter, and if anything further can be done to strengthen the hands of Representative T. H. Tongue when the question of giving Tillamook bar twenty-two feet of water at low tide comes before that committee now is the time to do act. We do not know whether it is advisable or not, but if it is necessary the citizens should send a person of some ability from this county to Washington to plead before the committee for the improvement of the bar.
The Headlight was not far wrong in its prediction in its issue of September 27th when it said that McKinley would have 293 electoral votes, and that in the issue of October 11 when we stated McKinley would poll two votes to Bryan's one in Tillamook county, thus giving the president a plurality of 300 votes; also that Bryan would be shy 200 and McKinley from 50 to 75 votes what they were in 1896, when McKinley's vote was 691 and Bryan's 537. Home newspapers are not far wrong in gunging the public pulse. Now for the future Who will be the fortunate individuals nominated on the next republican county ticket? And by the way the democratic vote is decreasing in Tillamook county. How many noses will they be able to count in June, 1902? We don't want to give our friends on the other side of the fence a don't care kind of a feeling or take all the fight out them, but by continuing to discuss political issues fairly and intelligently from time to time we hope to see a lot more democrats come in out of the cold by the Headlight working along those lines. Fortunately the party which has a live newspaper, as some of the democrats already to their sorrow realize, for one of our democratic subscribers remarked "You're knocking the stuffin' out

of the democratic party in this county and almost made a republican of me."
Commenting upon the discussion that is now going on in regard to the agitation to get common point rates for Astoria, the Oregonian says: "The Oregonian will endeavor, in few words, to state the contention raised by Mr. Hammond in behalf of the Astoria road against the O. R. & N. He insists that it is the duty of the O. R. & N. to bear the charge of transportation of the products of the country between Portland and Astoria. But the O. R. & N. has no rail line between these points, and doesn't see it that way. Stated in different terms, Mr. Hammond's contention is that the O. R. & N. should share its earnings with his road—that is, that it shall take from the earnings of its lines a proportional sum and allow that sum to the Astoria line. He wants to make earnings for his road, which is a laudable purpose. But the O. R. & N. prefers to use the river as the cheaper method of transport; and its position seems to be that, if it is to be required to bear the charge of traffic between Portland and Astoria, it has a right to select the natural channel and the cheaper one. The Oregonian is unwilling to take part in this contention, for the contention grows out of a transportation problem, which must be dealt with by the principals; but since the discussion has become public, it makes a brief statement of the positions of the parties, as it understands them. The O. R. & N. ought to have built the road to Astoria.

Where is Trevor.
Francis Trevor, baker and grocer, has disappeared. He was put aboard the 6 o'clock O. R. & N. train last Saturday evening, presumably bound for the East. His present whereabouts are unknown, and there is considerable speculation as to why he went.

Trevor is about 54 years old, and for several years has conducted a combined bakery and grocery established at 289 First street. He recently received a letter from a daughter in England, telling him that a fortune had been bequeathed to him, and he is said to have celebrated the occasion by getting drunk. When he went aboard the train Saturday night, he was accompanied by the car by M. J. MacMahon, an attorney of this city, who says that he was helping the old man to get away to England, to claim the fortune that is awaiting him. Trevor was under the influence of liquor at the time according to Police Detective Weiner, and did not seem to know what he was about.

All this occurred last Saturday. The first of the present week, MacMahon appeared with a bill of sale of Trevor's store property, to a man named Michaels. This was contested by F. M. Mulkey, in behalf of a creditor of Trevor's. Because of some error in connection with the bill of sale, the Sheriff's jury, which was drawn, decided that the bill of sale could not stand. At this trial it was estimated by Mr. Mulkey that there were suspicious circumstances connected with the hurried leave of Francis Trevor.

The question now is, where has Trevor gone, and did he know what he was about when he left Portland? Mr. MacMahon says he did, and Detective Weiner says the old man did not seem to know what he was about. William Trevor, the son, and F. M. Mulkey, are looking into the matter closely and expect soon to have some trace of the father.

The story of the disappearance cropped out when the difficulty came up between MacMahon and Mulkey over the bill of sale. When he heard of the sudden departure, Mr. Mulkey asked Chief McLaughlan to look into the matter, and at the same time filed a suit, presenting his claim of \$45, \$15 of which has been assigned by him to F. M. Stark, due for legal services.—Evening Telegram.

Francis Trevor and his son figured in a

case in the circuit court of this county last spring, and it will be noticed by the transfers in this issue that the land in dispute has been deeded to MacMahon.

Circuit Court.

The only criminal case to come before Judge G. H. Burnett at the circuit court on Monday is that of the State vs. Fred J. Newton, who is charged with unlawfully stabbing and wounding Harry Mitchell in this city. The other cases on the docket are:

W. J. May, plaintiff, vs. Florence H. Hardman and S. M. Hardman, defendants. Action for money.
E. W. Brown, plaintiff, vs. W. W. Conder and J. W. Wallace, partners doing business under the firm and style of Conder & Wallace, defendants. Action to recover cattle.

Judge F. D. Winton, of Astoria, has been appointed by the A. O. U. W. as grand lecturer of that order for the State of Ohio. He has left for the scene of his duties, and will be absent several months.

George Bailey, who has been prospecting on the headwaters of Johnson's Creeks for years, recently found an odd bed of porphyry that carries free gold, and has sold out to a California company for \$40,000.

Edward Rice, convicted of the murder of Matt Mailey, at Wardner, Idaho was on Monday sentenced at Wallace to be hanged on the last day of the century, December 31. His wife was granted a divorce in Spokane Monday on the ground of cruelty.

Sheep and goat-raisers in the vicinity of Monroe, are greatly alarmed over the abundant growth this season of the poison fungus or toadstool. Goats and sheep seem to have a great liking for the stuff, and its poisonous qualities are sufficient to kill the animal which eats it.

The body of John Adams, the 9-year-old boy who mysteriously disappeared two weeks ago, was found at Astoria on Saturday evening in the river under Fisher's wharf, and only a short distance from where the boy is supposed to have fallen overboard.

Discoveries of pearl in the upper Mississippi River has caused a tremendous rush to the clam beds. Boats are crowded the river, and more than 1000 persons are encamped along the river banks. The finding of a few thousand dollars' worth of pearls started the raid. One of the pearls recently found weighed 100 grains, and is said to be the largest pearl yet taken from the river. It was sold for \$3000.

Woodburn is to have a good water system and electric light plant. A 30-year franchise was granted A. B. Kurtz for both enterprises at a meeting of the Council. The Council also entered into a two-year contract with Mr. Kurtz for lighting the streets and public buildings. Now that a good water supply is assured, the town will purchase hose and provide ample fire protection.

Significant announcement is made in view of the reported agreement of five South American republics to apply arbitration in the settlement of their disputes that Chile is about to reduce her navy. The Government will sell one third-class cruiser to Ecuador and another to Peru and two torpedo boat destroyers to Japan. The fact that one of the warships will be sold to Peru, which is one of Chile's opponents in the Tacna-Arica dispute, gives additional weight to the declaration that a settlement of the controversy will be effected soon.
