STATUS OF NEHALEM LINE.

Much Preliminary work Done And Better Grand Found.

From the Oregonian.

February 2, the Portland, Nehalem & Tillamook Railroad Company was incorporated and since then surveyors have been in the field reconnoitering the country for better routes than those previously known. They have found easier grades than old surveys showed and have added a good deal of accurate information regarding the native resources of the region. An examination by prospective bond buyers is now in progress.

The first six weeks of the incorporation were consumed in correspondence and interviews with some of the transcontinental lines to ascertain whether trackage into Portland could be had and on what terms. As all the transcontinental lines are combined in interests, no action regarding new lines is taken without their consultation and acquiescence, hence it was not until after the Southern Pacific annual meeting three weeks ago that any definite knowledge was secured as to what railroad connections the Portland, Nehalem & Tillamook Railway, could make with other lines. As that company was incorporated purely for protection of Portland's interests in the Nehalem country in order that the local traffic should not be diverted to other points, the company, after careful consideration, recently resolved not to connect with any other railway except in or around the suburbs of Portland.

A surveying party started out some weeks ago to the passes on the Coast range in order to see if it were possible to reduce the grades shown by the old surveys. This party has been successful and as a result, instead of following the Upper Nehalem pass formerly surveyed, where the divide was crossed on a two per cent grade, a pass some miles further south has been discovered which if a dopted will certainly reduce the grade to 1 1/4 per cent and leave no occasion for a tunnel. This survey party is still in the field and when it shall return, in a few days, action will be taken by the board of directors definitely locating the route through the Coast range to Nehalem and Tillamook Bay.

The entrance into this city is still undetermined for the reason that the tunnel route into Portland on a 1 per cent grade will cost \$270,000 to \$336,000 more than by connecting with the Southern Pacific at Hillsboro or Oswego, or with the Northern Pacific 11 miles from Portland at the Cornelius gap. The bondholders-to-be, having no special or local interests in Portland, and merely desirous of a sound investment for their money, are in favor of that route which will cost the least money from the Nehalem to get into this city. Although the Portland, Nehalem & Tillamook Company is an Oregon incorporation, the stock which its subscribers possess is too limited to dictate terms, and consequently much time is lost in trying to reconcile all interests, while the promised Scappoose branch of the Northern Pacific is used to lead investors to believe that Tacoma is the proper place to lead the traffic of the Nehalem country.

Representatives of these bondholders to-be are here now looking into these matters and express surprise at the traffic showing. They find that although timber cruisers and United States estimates of Nehalem and Tillamook timber average 35,000 feet to the acre, yet taking the average to be only 20,000 feet to the acre the freight money to be earned by railroads building into the Nehalem and Tillamook country, at \$1.50 per 100 feet, carried to Portland in logs or lumber would be \$39,074,000.

Edward Rosewater, editor of the Omaha Bee, is quoted by the Times as saying, "William J. Bryan, in my opinion, will be a candidate for Governor of Nebraska next year. Mr. Bryan still exerts a wide influence in the state and if he receives the gubernatorial nomination, he will be a very hard man to beat. If elected Governor, he will hope to secure a Democratic Legislature, in which event he will seek an election to the United States Senate to succeed Governor Dietrich, whose term will expire in 1905. HEAD WAS SEVERED

"Black Jack" Kitchum Noted Desperado Hanged.

CLAYTON, N. M., April 26.—Thomas E. Ketchum, alias "Black Jack," the train robber, was hanged at 1:21 P. M. today. The rope broke, but his head was jerked off.

The execution took place inside a stockade built for the occasion. The inclosure was crowded, 150 spectators having been admitted.

When Ketchum mounted the platform at 1:17 his face was very pale, but his eye swept out over the crowd coldly and boldly, as if he had no fear. A priest stood at his side, as the rope was put around his neck. The condemned man had consented to this at the last moment.

Ketchum declined to make a speech before the noose was put around his neck. He merely muttered "Good by," then said, "Please dig my grave very deep," and finally "all right, hurry up." His legs trembled, but he kept his nerve.

When the body dropped through the trap the half-inch rope severed the head as cleanly as if a knife had cut it. The body pitched forward, with blood spurting from the headless trunk. The head remained in the black cap and flew down into the pit.

Some men groaned and others turned away, unable to endure the sight. For a few seconds the body was allowed to lie there, half doubled up on its right side, with the blood issuing in an intermittent stream from the severed neck as the heart kept on with its mechanical beating. Then with cries of consternation the officers rushed down from the scaffold and lifted the body from the ground.

It was only then apparent exactly what happened. The drop of the body was seven feet, and the noose was made so it slipped easily. Ketchum was a heavy man the weight of the body with the easy-running noose caused the rope to cut the head cleanly off.

Dr. Stadk pronounced life extinct in a jittle over five minutes from the time the body dropped through the trap. It was stated too much of a drop was given for so heavy a man. Sheriff Salomon Gircie superintended the execution, and himself let the trap drop.

Surprised Filipinos.

MANILA, April 28.—Captain Wilson Chase, with a detachment of the Twentieth Infantry, April 26, surprised the camp of the insurgent General Cailles at Dugot-Dugot, situated nine miles northeast of Cavinti, in the Province of Laguna. Cailles was at his camp at the time of the American attack, but managed to escape. Captain Chaic's force captured his Adjutant-General, five others of his staff officers, 14 men, 20 rifles, a large amount of ammunition and stores, and all the papers and personal effects of the Filipino General. Major Velo, insurgent, was killed during the engagement, as were Corporal McGill and Private Tipps, both belonging to Company A, of the Twenty-first. Several columns of the American troops continue vigorously to pursue General Cailles.

General Cailles recently offered a reward of \$10,000 for the head of Captain Edward N. Jones, Jr., of the Eighth Infantry. For more than a year past Cailles has commanded the insurgent forces operating to the east of Bay lake, not far from Manila. He is said to be a French half-breed. He has a reputation for vindictiveness and cruelty, and is one of the two or three Filipino leaders still in the field who have clearly ignored the

observances honorable warfare. The society of Mando-Ducats, whose practice it was to assassinate and bury those of their countrymen who accept American sovereignty whenever the latter fell into their hands, operated with the cognizance, if not the support of General Cailles. If Cailles were captured it is doubtful if he could claim immunity for past actions under the terms of the amnesty. In January of this year Cailles offered a reward of \$10 apiece for the heads of all Americans brought to him.

Slack Run Of Salmon.

OREGON CITY, Or., April 27.—The run of salmon is proving disappointing thus far. Monstrous sturgeon are tearing the nets to tatters and the fishermen are becoming disheartened over their misfortunes. Of course some salmon are being caught, but the number is small compared with other seasons.

When a fisherman has a net torn to pieces by a sturgeon, the temptation to kill the fish overcomes his desire to abide by the law. One fisherman this week sold an 850-lb. sturgeon, which he captured in his net, at 3 cents per pound. It is thought the buyer took it to Portland and spirited it into a big fish house. The man who had bought it began to study the law. He found that while it was unlawful to take sturgeon, nothing was said about buying or having them in one's possession. Then he began to carve the denizen of the deep. He obtained 130 pounds of cavier, which he sold for 50 cents a pound, thereby obtaining \$65. As he had paid only \$25.50 for the fish, he was already ahead of the game. The meat of the fish he sold at 10 cents a pound as "sea bass," and as there was 500 pounds of it, he received \$60, thus clearing \$99.50 on one fish.

Klondike Clean-up.

VANCOUVER, B. C., April 27.—The steamer Amur brings news of the Klondike clean up, which is being vigorously prosecuted. Sluicing is in full operation, the thaw having given plenty of water. The output is estimated at not less than \$25,000,000. Many experts say it will reach \$30,000,000.

Stampede are still rushing to Montana Creek, which is now more staked than any Klondike creek. Stampede are also going to the Gold River.

Owing to the thaw caused by good weather, Dawsonians are looking for an early opening of the river.

The Dominion gambling-house, one of the largest in the Klondike, has closed, owing to the loss of \$40,000, April 13.

The Dawson Board of Trade has appointed a committee to interview the railroad company and river transportation companies in an effort to get reduced freight rates.

Ore going \$50,000 to the ton has been found at a mine on Twelve Mile Inlet, near Ketchikan.

The Controller of the Treasury has decided that postal money orders are payable only by postmasters upon whom they are drawn and to whom notice of the issue thereof has been sent. It has been the practice heretofore to cash money orders at postoffices other than those on which they are drawn and for the postmasters cashing such orders to turn them into the Postoffice Department as vouchers.

Frederick P. Fish will take office as president of the American Bell Telephone Company, and of the American Telephone Company on July 1 next. His salary will be \$100,000 a year. He is 47 years of age and a graduate of Harvard University and Law School.
