The Astoria rate war is over, Monday the representatives of the various lines, who have held several conferences on the subject recently, reached an agreement as to freight and passenger rates, to go into effect June 1. It is asserted on all sides that the exceedingly cheap rates which have prevailed between Portland and Astoria and seaside points will never be known again, and that all the lines will hereafter charge a living and reasonable rate. By rail the fare to Astoria will be \$2 for a single trip, or \$3 round trip. On all steamers it will be \$1.75 for a single trip and \$2.50 for a round trip. *
In a letter to the Oregonian on the oil prospects in this state, Mr. J. H. Fisk among other things remarks: "Of the little part of Oregon that I am familiar with, I might mention a few places as geologically favorable for oil boring, and these are: Columbia, Washington Yamhill and Tillamook Counties and perhaps many other counties further south, and as favorable as along the foothills of the Blue Mountains; but I do not wish this to be taken as authority to bore for oil until a thorough examination is made of the country. No discussion of the subject of petroleum can fail to bring up the question of its origin. The question is not settled, neither is it likely to be settled in the near future, owing to the preponderance of theory over facts."

Our Prohibition "Scraper."

DEAR SIR,—Kindly give space in your columns to the following:

In last week's issue of your paper you printed an extract from a letter written by a Catholic priest, and in which he asserts that drunkenness and disorder among the soldiers have increased greatly since the anti-canteen law went into effect, and he makes special mention of conditions among the soldiers stationed near Detroit.

Capt. Starkweather, head of the police in the precinct in whose jurisdiction falls the control of the soldiers when on their larks in the near by saloons, said to a member of the "New Voice" staff, "There has always been well-nigh unlimited drinking at the 'outside resorts' on every pay day since I have had charge of this district, but there have been no unusual demonstrations or scenes of disorder since the beer canteen was abolished." And First Lieut. Marquardt, who has been on duty for nine years in this precinct, emphatically corroborated the captain's statements. These men ought to be more competent witnesses than an occasional visitor to the fort can possibly be.

One Detroit saloon-keeper put it this way: "You see, the boys used to get started all right on an innocent little spree at the canteen and then they would pile in here to get the real stuff, but they don't do that now the way they used to."

It has been proved over and over again that the removal of the canteen, or army saloon, has not been detrimental to the moral condition of the army anywhere, and the papers that have been busy asserting the contrary have been openly convicted of down right lying.

In its issue of April 25, 1901, "The New Voice" editorially challenged the war department to present documentary evidence of the evil effects of the anti-canteen law, such as the increase of intoxication and disorder among the soldiers, the opening of new saloons contiguous to the army posts, giving their location and names of proprietors, etc. So far the War Department has not presented such evidence. It ought certainly to be an easy thing for the War Department to do, if there is any truth in these reports.

Early in January, this year, Sergeant Buzzacoat made a proposition to the War Department to establish a temperance canteen at his own expense in the Philippines, fitted up comfortably for the accommodation of 1000 men, provided with neat lunch counters for serving hot coffee, tea, chocolate, fresh milk, iced tea, lemonade, etc. But the War Department laid aside this excellent offer with the statement that soon the army saloon, or canteen, would be open again, and it would do no good to establish this temperance canteen. See the point?

Do you know, Mr. Editor, that a committee of Chicago preachers lately visited Fort Sheridan, near Chicago, and reported that no new saloons had been opened there since the anti-canteen law had gone into effect, and that there had been no increase in drunkenness? Do you know that the ministers' association of Manila investigated matters there and unqualifiedly deny that the canteen has been conducive to temperance. In part they said: "The only effect of the canteen was to multiply the number of saloons where the soldiers could drink—the saloon in the barracks keep temptations always before the men, offers opportunities to non-drinkers who never would go into a saloon, and is simply one more saloon added to the too numerous outside places—the chief objection to the canteen is that it keeps under a man's very nose the opportunity to drink. If he is a man who seldom drinks it tempts him to become immoderate."

Ought you not, Mr. Editor, to investigate carefully such a report as you printed last week before giving it place in your columns lest you be found lending your influence against the moral welfare of our soldiers and of our country as well.
