

SHERIFF'S TAX SALE.

By virtue of a Delinquent Tax Warrant issued out of the County Court of the State of Oregon, for the County of Tillamook, bearing date of March 19th, A.D., 1901, and under the seal of said Court, directed to me as Sheriff of said county, commanding me in the name of the State of Oregon, to levy on and make sale of the goods and chattels of the delinquent tax payers, named in the delinquent tax roll of said county for the year 1899, thereto attached, and if none be found, then upon the real property set forth and described in said delinquent tax roll, or so much thereof as shall satisfy the amount of taxes charged thereon, together with the costs and expenses of levy and sale;
