Some of the Portland people who have visited the Tillamook Creamery Company's factory in this city the past week or so have expressed their surprise at the growth of the dairy industry in this county, and it is amusing to see their eyes bug out when they behold the product of that factory, for there are nearly 3000 cheese, weighing about 33lbs. each, in the curing rooms. To give some idea of the growth of the industry, it was only a few years since that this factory received all the milk in that vicinity, varying about 10,000 pounds a day. Since then a number of other large factories have been erected only a few miles distant, yet the Tillamook Creamery Company is receiving more milk this year than any year previous. We must speak a kind word for Mr. Miller, the cheese maker at this factory, and also those of other factories, for the courteous manner in which they receive visitors and explain to them the process in the manufacture of cheese.

### Gamblers are Sneaking.

When gamblers fall out and disagree they generally tell how the cards are manipulated, fixed or marked so as to make it almost impossible for the novice at the business to win at another man's game. This is what was brought to light in a case which was tried in this city last week. C. L. Thompson, late proprietor of the Palace saloon, swore out a complaint against Charles Howe, the present proprietor, for gambling. The complainant told how, on the 27th July, Charles Howe was the dealer in a game of 21, and that the parties who were playing were betting money and losing. He also stated that the dealer was playing with marked cards, and told in what way these cards were dealt. Alfred Gubser testified that he had \$20 when he started in to play, but as Howe won it he was broke when he got through. The court bound Howe over to the circuit court, \$150 being the amount of the bond.

Charles Howe and H. W. Kretzer were charged with having a nickel-in-the-slot machine in operation at the palace saloon and were each fined \$10. R. M. Watson was one of the star witnesses in this case and testified to playing the machine and winning money. C. L. Thompson made the complaint.

Tillamook is now going to get in line with other cities by having a series of plays weekly, the first of which will be "Ole Olson, Jr.," to be played for the benefit of the band, next Saturday evening.
