When it comes to leasing streams in Clatsop county the owners of property are given an opportunity to be heard by the county court and to protest against their rights being taken from them. We wish to point out how different it was in Tillamook, where the property owners were treated as though someone thought "Be damned the property owners; they've no right to be consulted."

Between Friday and Wednesday some parties broke into A. M. Austin's house at Netarts. They first took out a pane of glass, and finding they could not get in that way they removed the sash. They ransacked the house, broke open a trunk and it is thought they have stolen a number of things, including a Winchester. The burglary was not discovered until Mr. Austin's father returned to the place on Wednesday.

The government dredger has been taken to the wharf at Hobsonville to do some dredging there so that the steamers can lay at the dock without resting on the ground at low tide. Considerable blasting will have to be done and the work will take about four weeks, at the Truckee Lumber Co's expense, as they have borrowed the dredger from the government for that purpose, Inspector Frank Batter being in charge.

A correspondent wants to know why only one of the gambling resorts was picked out for prosecution and those of long standing allowed to proceed without the least interference. It is somewhat unfair, we must admit, but will not attempt to answer it now. First, we will refer the matter to the gamblers themselves; and second, to the officials who have sworn to enforce the laws. Speak out, gentlemen, speak out.

Dairy Commissioner J. H. Bailey says you cannot begin to talk upon any subject to a Tillamook county rancher ex-

cept cheese. We differ with him. It took the commissioner a long time, in his official capacity, to locate Tillamook, and since he did so last month, the subject of dairying cannot be mentioned without his mind reverting to Tillamook. He must be judging the dairymen of this county by himself. And like ex-Governor Pennoyer he has shown his ignorance of the best part of Oregon until a few weeks since.

It appears to us that many of the oil companies recently formed in this state are being manipulated by those who expect to make a "graft." We have had some experience in this direction in Tillamook, where promises were made that operations would commence within 60 days, but we fail to see any indications in that direction, and probably the Tillamook Paraffine Company is defunct, if it ever were a company in the strict sense of the word. Such proceedings only discourages those who would assist legitimate enterprises. We do not wish to give people cold feet, but we certainly would like to see an effort made to ascertain whether there is oil in this county.

The Tillamook Creamery Company will send several cheese to the state fair at Salem. This is a move in the right direction, for Tillamook has been somewhat backward in exhibiting the products of the county. We hope that other cheese factories will follow suit so that Tillamook cheese will have a large exhibit. And if this county can carry off several of the premiums it will give the factories where the cheese is made a wide reputation. For each factory to send an exhibit would not entail much bother, but it will go a long way to advertise the county and establish the fact that Tillamook cheese is the best on the market. We have a number of first-class and experience cheese makers in the county who pride themselves upon the excellent cheese they are turning out, and for that reason, let these cheese makers have an opportunity to exhibit their product. The directors, patrons or owners of the cheese factories in this county should encourage them to do so.

Mr. M. G. Wilkins, who is working in this county in the interest of the Ancient Order of United Workmen, has succeeded in securing a large number of applicants for membership, among whom are several who dropped out and are now applying for readmission. The first batch of candidates were initiated on Tuesday evening in Star lodge, and the prospects look bright for the membership of this lodge to be doubled before Mr. Wilkins is through with his work in this county. The HEADLIGHT has so often expressed itself on the merits of this order and the duty every man owes to his wife and family in providing for them in case of his death, that it is not necessary for us to elongate upon them at this time. Court Denied the Petition.

ASTORIA, Aug. 19.—The petition of the Wheeler Lumber Company of Nehalem for a 49-year lease on the Nehalem River and several of its tributaries for floating logs and lumber was today denied by the County Court. Saturday afternoon a meeting of about 50 of the owners of property along these streams was held at Jewell to consider the advisability of giving the lumber company rights of way across their property. After listening to the arguments of the company's representatives, motions were unanimously carried against the rights-of-way and requesting the County Court not to grant the Nehalem Lumber Company or any other person or corporation the exclusive right to use the Nehalem River or any of its tributaries. The action taken at this meeting was reported at the session of the County Court this morning as was also a letter from Judge Magers, attorney for the Wheeler Lumber Company, saying that he would not urge the granting of the petition any further. The court then made an order denying the petition.
