TO SEA IN A BALLOON.

Captive Airship Turned the Tables on Its Captors.

SAN FRANCISCO, Nov. 3.—A captive balloon, containing nine people, one woman and eight men, broke from its moorings at Eleventh and Folsom streets last evening, and floated to the neighborhood of Redwood City, about 20 miles distant.

SAN FRANCISCO, Nov. 3.—The nine occupants of the car of the balloon which escaped from this city yesterday afternoon returned safely today. The balloon landed near Pescadero, 50 miles from this city and but a short distance from the ocean. The balloon was in the air nearly two hours, and at one time was out to sea, but was blown back over the land.

Those who made the involuntary trip were: Ed P. Dudley, the aeronaut; A. L. Dodge, Ed Foster, Jr., Walter Leon, C. P. Vildecq, J. A. Leonard, M. L. Howarth, John A. M. Swift and Mrs. I. P. Cassano. When the balloon broke its bonds it sailed away in a southerly direction. South of Redwood City it struck another air current which took it towards the ocean over the summit of the Coast Range. Nine miles from La Honda and about six miles from Pescadero lies Betty Thompson's place. Thompson was up and out when the balloon came along by Warr's mill, the grappling hooks slipping through the trees and raking along brushy patches of ground. By this time much of the gas had been let out of the balloon and the power was weak. The rope that had snapped and caused the captive to run away was sweeping along the ground, and when it came within Thompson's reach he grasped it and bore down with all his weight. This stopped the flight. Soon the balloon was brought to the ground, and the overjoyed passengers and the aeronaut alighted and took supper with Thompson.

A. L. Dodge, one of the passengers, describing the trip, said that the balloon first started toward Oakland, and after circling about for a time drifted southward and became stationary for a short period. Then, in response to a breeze from the eastward, it sailed over the San Mateo hills and stood far out over the ocean. The hearts of all the occupants of the wicker cage were filled with fear as the prospect of being dumped into the ocean stared them in the face. Twice, according to Dodge's story, the balloon dipped close to the surface of the water, but rose again each time to a considerable altitude. Finally, a breeze from the eastward, the balloon and carried it back over the land and, after dragging the cage through the tops of a grove of trees, landed on a side hill six miles from Pescadero.

"It was a terrible experience," said Dodge, "and I wouldn't undergo the same adventure again for any consideration. Everybody was more or less shaky, while the lady passenger and two of the men were so frightened and sick that they sat in the bottom of the basket throughout the trip. We were all pretty glad when we finally landed without sustaining any injuries except from fright."

President Roosevelt's Thanksgiving Proclamation.

WASHINGTON, Nov. 2.—President Roosevelt today issued his proclamation fixing Thursday, November 28, as a day of national thanksgiving. It reads:

"A Proclamation: The season is nigh when, according to the time-hallowed custom of our people, the President appoints a day as the especial occasion for praise and thanksgiving to God.

"This Thanksgiving finds the people still bowed with sorrow for the death of a great and good President. We mourn for President McKinley because we loved and honored him, and the manner of his death should awaken in the breasts of our people a keen anxiety and a resolute purpose not to be driven by calamity from the path of strong, orderly, popular liberty, which, as a Nation, we have thus far safely trod.

"Yet in spite of this great disaster, it is nevertheless true that no people on earth have such an abundant cause for thanksgiving as we have. The past year in particular, has been one of peace and plenty. We have prospered in things material, and have been able to work for our own uplifting in things intellectual and spiritual. Let us remember that, as much as has been given us, much will be expected from us; and that true homage comes from the heart as well as from the lips and shows itself in deeds. We can best prove our thankfulness to the Almighty by the way in which, on this earth, and at this time, each of us does his duty to his fellow men.

"Now, therefore, I, Theodore Roosevelt, President of the United States, do hereby designate as a day of general thanksgiving Thursday, the 28th of this present November, and do recommend that throughout the land the people cease from their wonted occupations and at their several homes and places of worship thank the giver of all good for the countless blessings of our National life.

"In witness whereof I have hereunto set my hand and caused the seal of the United States to be affixed.

"Done at the city of Washington, this 24 day of November, in the year of our

Lord the thousand nine hundred and one, and of the independence of the United States the one hundred and twenty-sixth.

Kidnaped by a Boy.

GREAT FALLS, MONT., Oct. 31.—Late this afternoon G. W. Ryan, a prominent grocer of this city, received a note directing him to leave \$1500 at a certain point, as a ransom for his 6-year-old son. Unless the demand was complied with by 9:30, the threat was made that fine pieces of glass would be rammed into the child's eyes and his hands cut off. The police were notified and a search was made for the boy and the kidnaper. About 6 o'clock the missing child walked into his father's store, gagged and crying, but otherwise unharmed. He said he had been kidnaped shortly after school by a boy named Southwick, who had first taken him to his home, and afterward to a spot he could not locate. The Southwick boy was soon found and arrested. He is about 12 years old, and at first declared that he had been told to steal the Ryan boy and write and deliver the note by two men. Afterward he confessed that he did the deed of his own volition, and that he had no accomplices. He expressed no repentance and said: "I would have hit the old man for \$8000 if I had thought that he would have stood for it." He refused to tell where he had the child secreted, or how the boy got away. Little Ryan is too nervous and scared to tell a connected story of his escape.

Botha Shared in Fight.

LONDON, Nov. 2.—Lord Kitchener has reported a disaster to the British near Bethel, in eastern Transvaal in which two guns were lost and several officers killed or wounded, and fifty-four Boers killed including Colonels Benson and Guinness.

The officers killed include Colonels Benson and Guinness. Eastern Transvaal. It appears that General Botha, who had been joined by another British commando aggregating 1000 men, attacked Colonel Benson's rear guard October 30 on the march and captured two guns, but was unable to keep them. Colonel Benson falling mortally wounded early in the fight. Major Woods Sampson took command, collected the company and took up a position for defense about 100 yards from the entrenchments prepared by the Boers. The captured guns were taken to Bethel, but neither side could touch them. The Boers made desperate efforts to overwhelm the whole British force, charging repeatedly right up to the British lines, and being driven back each time with heavy loss. The defense was stoutly maintained, notwithstanding the stubbornly and successfully maintained through the whole of the following day and the next night, until Colonel Barter, who had marched all night on the morning of November 1. The Boers then retired. Their losses are estimated at between 300 and 400. Colonel Benson did not long survive. Not only did General Botha direct the attack, as already cabled, but he personally shared in the fight.

"To be confined one year in such place as the Secretary of the Navy may direct, to do extra police duty during that time, to lose all pay except \$2 a month for prison expenses, and the further sum of \$20 to be paid him at the expiration of his confinement and to be dishonorably discharged from the service of the United States," is the sentence imposed by court martial upon John W. Stoll, a third-class electrician of the receiving ship Columbia lying at the New York navy yard, for foul abuse of the late President McKinley.

According to news from Vienna, it is stated that a well-known Macedonian brigand has been instructed to obtain information as to whether Miss Ellen M. Stone is still alive. Two other brigands, well acquainted with the country, have been commissioned by United States Consul General Dickinson to try and get in touch with the "missionary's" captors. The Prefect of the Sofia Police has also sent two messengers. Miss Stone's release is again represented as being imminent.

The control of the Elkton Consolidated Gold Mining Company on the property of which a remarkably rich strike was made recently in Colorado, has passed into the hands of Eastern capitalists for a consideration based on a valuation of \$6,875,000 for the entire capitalization.

The trial of John Considine, charged with the murder of Chief of Police Will Meredith began in Seattle on Monday. The attorneys for the defendant renewed their motion for a continuance, which was again denied.

EXPOSITION ENDED.

Financial Loss Will Be in the Neighborhood of \$3,000,000.

BUFFALO, Nov. 2.—The Pan-American Exposition ended at 12 o'clock tonight. At midnight President John G. Milburn pressed an electric button and the lights in the famous electric tower grew dim for the last time. Slowly, one by one, the lights on post and pinnacle and tower faded away. A corps of buglers standing in the tower sounded "taps," one of the greatest glories of the exposition—the electrical illumination—passed away, and the exposition was ended.

The exposition has not been a financial success, but it is believed the benefits derived from it will be of great value to the commercial interests of the country. The primary object of the exposition was to advance the friendly relations and commercial intercourse between the United States and the other countries of the two Americas. In this respect it has been a decided success.

The financial loss will be in the neighborhood of \$3,000,000. The statement to be issued by the officers of the exposition, setting forth the expenditures and receipts, will be made public some time this month.
