Wade and Dalton to Hang.

Jack Wade and William Dalton will be hanged in the Jailyard at the Court-house, at Portland, on Friday, January 31. Sentence was passed on Tuesday morning by Judge Frazer on Wade, and by Judge Cleland on Dalton. The men will be confined in the County Jail in the meantime. Each of them addressed a few remarks to the court and spectators, but the air of solemnity that one might expect at such a time was lacking.

This may have been due to the bearing of Wade, who wore his habitual smile and assured the court when it was all over that he was much obliged. Each of the murderers still maintains that the other fired the shot which killed young Morrow, but Dalton, who has got "religion," assured his listeners that he would willingly part with his life, if it would prove an example to the young men about him.

A large crowd filled the courtroom to hear the death penalty imposed on the men. The date set for the execution is the earliest that can be set, according to the law, and yet be on Friday, the usual day for hangings.

When Judge Cleland stated it was the time set for passing sentence on W. H. Dalton, unless cause could be shown to the contrary, Clarence Veazie said his client had a few words to say.

Dalton rose from his seat, walked to the Judge's bench, faced the courtroom full of people and said:

"I hope and trust what I have done will be an example to the young men I see here. I am innocent of the crime. Jack Wade fired that shot. If my life is of any use as an example, I am willing to give it up."

Then Judge Cleland pronounced sentence: "You have been informed against and charged with the crime of murder. A jury has found you guilty, and it is the duty of the court to sentence you. The judgment of the court is that you be imprisoned in the County Jail until January 31, and at that time be taken by the Sheriff or his deputy and hanged by the neck until dead."

Wade also addressed a few remarks to the court. He said:

"I have not much to say to you, men. I haven't anything to be scared of. I admit I deserve death for associating with such a man as that. There is no use of my saying anything. I said at first I did not fire the shot, and I say so now."

Judge Frazer used practically the same wording as Judge Cleland, in pronouncing the death sentence upon Wade and condemned him to be hanged at the same time as Dalton, January 31.

"I am much obliged to you," was Wade's comment upon the remarks of the court, although what he is obliged for is a mystery.

Both men were taken to the County Jail and placed in the condemned cells, where they can talk to but not seen each other. The death watch will be placed on them soon.

Clarence Veazie stated Tuesday morning he did not expect to take an appeal in the Dalton case, so the double hanging will doubtless take place as arranged.

After Annual Dairy Reports.

Food and Dairy Commissioner Bailey has just finished sending out circulars to the various creameries and cheese manufacturers of the state, asking the managers to transmit their report for the year 1901. There are 102 creameries and 82 cheese factories in Oregon, and according to law, these must make a statement of their output at the close of each year. The law does not comprehend the small dairies, but only those turning out over 25 pounds of butter or cheese per week. A blank form is enclosed, in which the name of the manufacturer is to be inserted, the number of cows, pounds of milk purchased, number of pounds of butter and cheese sold. The object of the law is to find out the total dairy output of the state for the year.

Maclay "Fired."

WASHINGTON, Dec. 24th.—Secretary Long has discharged Edgar Stanton Maclay, from his position as a skilled laborer in the Brooklyn navy-yard, Mr. Maclay having refused to resign when requested to do so. Mr. Maclay criticised Admiral Schley in his naval history as a "caitiff, poltroon and coward."

Secretary Long's action was taken by direction of the President, and followed a conference between the President and the Secretary, who took to the White House with him a letter from Maclay in response to the request for his resignation sent by the Secretary last Saturday. In this letter Maclay submitted that he could not be removed or be compelled to resign without definite charges being made against him and without having an opportunity to answer those charges.

Although the civil service rules give employees of the service the opportunity of answering charges that may be preferred against them, the President exercised his prerogative in the present incident and directed Maclay's removal, it being held that the latter was aware unofficially, if not officially, of the reasons which actuated the Executive in taking the course determined upon. Secretary Long said the action taken to-day would dispose of the case finally.

New York, Dec. 25th.—When seen at his home and informed of his dismissal from his position in the Navy Yard by President Roosevelt, Edgar Stanton Maclay said:

"I have written to the civil service authorities at Washington asking for a formal opinion on this subject. I shall be guided in my actions by the advice received from this source."

EMANCIPATED WOMAN.

She is Found in Italy as Well as in the United States—How She Works There.

Though in Italy the so-called "emancipation" of women is by no means so far advanced as in England or the United States, there are few countries in Europe where the political influence of women is greater than in Italy. The influence, though great, is not, however, always apparent, for it is chiefly exercised indirectly and privately by the women of the upper classes. Instead of forming themselves into associations and leagues and international unions and organizations and competing with political orators, the Italian women interested in political work quietly, and certainly not less efficaciously than their more "emancipated" sisters.

As a rule, Italian women work by means of the old French expedient, the salon. In Rome alone there are no fewer than a dozen salons devoted almost entirely to the discussion of political topics. Each salon has its own political "color," which is generally that of the husband or father or friends of the mistress of the house; but while the thread and web of the politics carried on in a salon is spun and woven by the men who frequent it, the personal influence of the mistress of the house acts on each one of her guests, modifying views, and softening, or it may be accentuating, the roughness of ambition. As long as they remain in their salon Italian political women are in every way admirable.

BEEES IN HIS HUNTING COAT.

Pockets Full of Honey for a Soldier When He Came Home from the War.

Asa Witham, a farmer of Blanchard, Me., has been a member of the Dover company, Maine volunteer militia, for two years, and is counted one of the best marksmen in his regiment. Last May when he was waiting for the government to call the troops to Augusta he went out one afternoon and shot six rabbits. On his return a messenger met him in the doorway and told him he must take the next train for the state capital. As his canvas hunting coat was wet with the blood of the rabbits he hung it up on the limb of an apple tree, remarking that it would be well washed by the time he returned from the war.

Witham was mustered in and went to Chickamauga, where he was on duty every day until a month ago, when his regiment was ordered back to Augusta.

He was sent home on a month's furlough. Being somewhat exhausted from a continuous diet of hardtack and bacon, he thought he would try his luck at partridge shooting before setting down to farmwork. The canvas coat was hanging from the limb in the orchard, but when Witham went to put it on he found that it was already occupied by a swarm of bees, which had taken possession of the garment during his absence. With the aid of a sulphur smudge fire he expelled the insects, and secured 22 pounds of white comb honey.

A Queer Verdict.

Upon the Isle of Man, where sheep-stealing is evidently a serious offense, John Dixon was recently sentenced to three years' imprisonment for it. The exact words of the jury were: "Not having satisfactorily accounted to the minds of the jury for the possession of the sheep, we find the prisoner guilty."
