Worst in Years.

ST. PAUL, March 16.—North Dakota and the Canadian Northwest has experienced the worst snow storm in many years, and the railroad traffic is practically paralyzed. The Northern Pacific and Great Northern have not moved a wheel for nearly 32 hours in the blizzard-stricken district, and have abandoned all efforts to do so for the present. The high wind has piled the snow in mountainous drifts and packed it in solid masses, many deep cuts being entirely filled. The temperature has been falling gradually, and is now at or below zero. Not a transcontinental train has arrived in St. Paul since Friday, and none is expected for several days. The Northern Pacific reports its west-bound Coast train, which left St. Paul yesterday morning, tied up at Fargo, the road beyond there being blocked. It will start a Coast-bound train tomorrow, and hopes to be able to get it through. The east-bound Coast train, due here Saturday morning, is held at Madan, N. D., and an effort will be made to move it tomorrow. Every effort is being made to keep the snow-bound passengers fed and warm, and for the purpose trains are being held at stations where there are accommodations rather than attempt to get through with a possibility of being tied up between stations. The Red River Valley division of the Northern Pacific, between Frankfort and Winnipeg, is entirely abandoned. No trains have attempted to run since Friday night, and the whereabouts of extra trains on this division are not known, as the wires are down.

General News of Interest.

When Senator Mitchell voted for the ship subsidy bill he was not expressing the carrying out the wishes of his constituents in Oregon. We hope the house will defeat the bill and that the Oregon congressmen will go on record as voting against it. According to a bulletin the Census Office made public there are 68 butter and cheese factories in Oregon, with a capital of \$223,409. The product for last census year included 1,975,357 pounds of butter, valued at \$440,599; 1,195,564 pounds of cheese; valued at \$135,981; and other products valued at \$62,742.

The ship subsidy bill has passed. In his closing speech on the ship subsidy bill Frye said he would accept the amendments offered by Allison, limiting the time of the operation of the measure because he believed they were in the interests of the bill. The vote on the Vest amendment stood 25 to 48, a strict party vote, with the exception of McLaughlin (S. C.), who voted with the Republicans.

Mrs. Eloff, wife of Mr. Kruger's private secretary, sailed for South Africa on Saturday, says a London dispatch to the Tribune. Her husband expects to follow her speedily. Opinion at The Hague is that Eloff will carry letters from Mr. Kruger, which may have a decisive effect on ending the war. The generalization is an elastic one, but without doubt well-informed people at The Hague are convinced that negotiations are in progress and peace nearer than is generally supposed.

Fuentes and Mazantini, the Spanish matadors, fought six bulls to death at Juarez, Mexico, in the presence of 10,000 Americans and Mexicans. The fight was full of action and thrilling incidents from start to finish, and many narrow escapes were made by the banderilleros and picadores. Five horses were killed in the ring and three taken out mortally wounded. Fuentes and Mazantini have just completed a tour of Mexico with a company of 12 artists who form the greatest bullfighting aggregation in the world.

There is no longer any doubt that Pension Commissioner Evans will, within the next few months, at the latest, sever his connection with the Pension Bureau, to accept from the President a position which will be a substantial promotion, but which has not yet been definitely selected. It is well known that Mr. Evans has the entire confidence of the President, and the latter will not consider the question of his retirement until a position entirely satisfactory to the Commissioner has been provided. No decision has been reached concerning a successor to Mr. Evans, nor will any action be taken until the President is thoroughly convinced that he has found a man of the same high character and sterling worth possessed by the present Commissioner in so high a degree.

Although six Republicans, four from the interior Northwest, voted against the ship subsidy bill, it passed the Senate easily yesterday by a vote of 42 to 31, and Senator Hanna is happy. McLaughlin, of South Carolina, voted for it, but he is only nominally a Democrat; he votes regularly with the Republicans on all important measures; therefore it may be said that the Democrats have the honor of having voted solidly against the measure, which, if left to the people of the United States, would be rejected at last two to one. The bill will in all probability go through the House and become a law; and the probable consequence will be a big ship trust that will want more and more protection until it can control the commerce of both oceans. It is such nefarious legislation as this that eventually will break the Republican party's back or neck.—Telegram.

Trinity Protestant Episcopal Church of Portland was badly damaged Monday by a destructive fire, which broke out owing to a defective flue, at the northeast corner of the building, at Sixth and Oak streets. The loss is about \$12,000 covered by \$16,000 insurance. Big holes are burned in the beautiful groined roof, the organ is damaged, and water is standing over the entire floor from end to end. The expensive altar cloths and part of the church furniture were pluckily saved by a member of the church choir, Gus Kramer, assisted by several women, who were sewing in the parish-house when the fire started. It is a question if the present church building will be repaired. Several wealthy members of the church think that the time has now arrived to sell the property and build a new stone church on the lot owned by Trinity corporation on Washington street, between Seventeenth and Eighteenth streets.

Big Students' Riot.

ST. PETERSBURG, March 16.—A student riot here, in which over 10,000 people engaged kept a large force of police and cavalry busy throughout the day. Probably 100 arrests were made, but the repressive measures were not so strict as on the corresponding Sunday of 1901. While many persons were injured, no fatalities were reported. The students placarded the city last night, announcing that they intended to hold a grievance meeting, and the authorities taking the hint, made extensive preparations. The whole police was called out, and the military was held ready for mobilization, cavalry patrols supplementing the mounted police. Additional squadrons of cavalry, light batteries of artillery and detachments of infantry were packed in the side streets. The crowds increased in the main thoroughfares until noon, when the cavalry officer in command of a squadron in front of the Hotel d'Europe begged the crowd there to disperse and go home. The demonstrators refused, and the mounted troops began slowly clearing the streets.

At 12:30 P.M., the students attempted to organize a procession in front of the hotel mentioned, singing revolutionary songs and shouting "Free Russia," "Down with the autocracy." The police and cavalry then charged, but used only their Cossack whips and the flats of their sabers. Many persons were hurt, but only a few were seriously injured. The fighting continued during the remainder of the afternoon, breaking out in fresh places continuously. One of the most severe fights of the day was concluded only a few minutes before the Czarina, in an open sleigh, passed the spot where it occurred. Carriages of the nobility and members of the imperial household were several times mixed up in the melees. The authorities made efforts to prevent bloodshed, and in this they were remarkably successful, considering the magnitude of the demonstration.

EMANCIPATED WOMAN.

The Is Found in Italy as Well as in the United States—How She Works There.

Though in Italy the so-called "emancipation" of women is by no means so far advanced as in England or the United States, there are few countries in Europe where the political influence of women is greater than in Italy. The influence, though great, is not, however, always apparent, for it is chiefly exercised indirectly and privately by the women of the upper classes. Instead of forming themselves into associations and leagues and international unions and organizations and competing with political orators, the Italian women interested in political work quietly, and certainly not less efficaciously than their more "emancipated" sisters. As a rule, Italian women work by means of the old French expedient, the salon. In Rome alone there are no fewer than a dozen salons devoted almost entirely to the discussion of political topics. Each salon has its own political "color," which is generally that of the husband or father or friends of the mistress of the house; but while the thread and web of the politics carried on in a salon is spun and woven by the men who frequent it, the personal influence of the mistress of the house sets on each one of her guests, modifying views, and softening, or it may be accentuating, the roughness of ambition. As long as they remain in their salon Italian political women are in every way admirable.

BEEES IN HIS HUNTING COAT.

Pockets Full of Honey for a Soldier When He Came Home from the War.

Asa Witham, a farmer of Blanchard, Me., has been a member of the Dover company, Maine volunteer militia, for two years, and is counted one of the best marksmen in his regiment. Last May when he was waiting for the government to call the troops to Augusta he went out one afternoon and shot six rabbits. On his return a messenger met him in the doorway and told him he must take the next train for the state capital. As his canvas hunting coat was wet with the blood of the rabbits he hung it up on the limb of an apple tree, remarking that it would be well washed by the time he returned from the war. Witham was mustered in and went to Chickamauga, where he was on duty every day until a month ago, when his regiment was sent back to Augusta. He was sent home on a month's furlough. Being somewhat exhausted from a continuous diet of hardtack and bacon, he thought he would try his luck at partridge shooting before setting down to farmwork. The canvas coat was hanging from the limb in the orchard, but when Witham went to put it on he found that it was already occupied by a swarm of bees, which had taken possession of the garment during his absence. With the aid of a sulphur smudge fire he expelled the insects, and secured 22 pounds of white comb honey.
