As they were shaking hands with the president, Mrs. White remarked that she and her sister crossed the plains to Oregon with an ox team in 1854. This aroused the President's interest and he reopened the conversation, chatting for some time with the pioneer, and expressing his admiration for the people who settled the West, and particularly Oregon.—Oregonian.  
The plank in the republican platform to raise the assessment on timber lands is a move in the right direction, and if carried out, as it certainly should be, will be the means of obtaining more money for road purposes. The increase in the assessment on timber lands need not be made burdensome, but raised enough to correspond with the actual value. As we have often stated, the present system of taxing every improvement a settler makes on his place and not increasing the assessment on timber land owned by non-resident speculators is unjust.  
Articles of incorporation have been filed with the County Clerk incorporating the Tillamook County Bank. The incorporators are W. W. Curtiss, M. W. Harrison and B. L. Eddy, the object being to conduct a general banking business, with the principal office for business at Tillamook City. The capital stock of the corporation is \$10,000, and divided into one hundred shares of \$100 each. The bank will be opened up as soon as safes and vaults can be obtained and a building erected. The bank will probably be located opposite the post office on the lot where Mr. T. Coates has his abstract office.

### FROZEN TO DEATH.

**Myo Coffman and Arthur Ward, Two Tillamook Boys, the Victims.**  
The people of Tillamook City were shocked on Sunday about noon when it became known that Coroner J. E. Tuttle had received a message from Trask stating that the mail carrier had come across the dead bodies of two men who had been frozen to death on the toll road between Trask and the summit. It did not take long to ascertain who the victims were, for it was known that Myo Coffman and Arthur Ward, two Tillamook boys, had left Charley Wells' farm at South Prairie about eight o'clock with the intention of crossing the mountain on foot. Ward was working for Mr. Wells, and while the latter was in this city on Friday evening his wife called him up on the telephone and told him to return home as Ward was going to leave in the morning. Wells spoke to Ward over the phone and advised him not to leave, and he did so when he returned home, pointing out the folly of taking such a journey at this season of the year, and especially as Ward had only a thin pair of shoes and his clothing was only of cotton texture. Wells thought he had him talked out of going and allowed him to remain in bed longer than usual without calling him. Ward got up between six and seven and told Wells that he was going to leave and would send the few dollars he owed him when he got work on the outside. Wells said it did not matter about that and persuaded him again not to leave, even promising to buy him a ticket to Astoria if he would not go. Wells told him they would never make it and would freeze to death, when Ward said he would die in the attempt.  
It appears that the mail carrier, who carries the mail from Trask to the summit and returns the same day, met the boys at the gate about noon when he came down with the mail, and spoke to them, but did not think they intended going on as they went towards the house. The next morning, when eight miles from Trask, and in the second turn of the zigzag, where there was between four and five feet of snow, he came across the body of Coffman frozen to death and lying across the trail. He hurried on to the summit to return to Trask. After re-passing the body of Coffman, and about two miles nearer the toll gate, he discovered the body of Ward. It was off the trail, and it seemed as though the boy had seen a place where he could get a little shelter, but in doing so he fell between two logs, and being exhausted had no strength left to extricate himself, where he soon froze to death with his wet and thin clothing. As soon as the mail carrier reached Trask he phoned to the coroner in this city for assistance.

Fortunately the moon afforded a little light and the party returned to the second zigzag, the horses passing up and down the trail, which had the effect of uncovering Coffman. Tuttle, with the aid of a lantern, discovered the body. It was strapped on the back of a horse, and when they started for the toll gate it was nine o'clock. On reaching the body of Ward it was packed in the same way.  
The team and rig, when about two and a half miles up the mountain, became stuck, and after remaining in that position for about three hours the driver went almost frantic with delight when he saw in the distance the lanterns of the returning party. Then another chapter of accidents occurred in break downs, and it was midnight before the toll gate was reached and five o'clock next morning when the party arrived in this city with the bodies. That of Ward was immediately shipped on the Sue H. Elmore to Astoria, where the boy's parents live, while the remains of Coffman were buried the same afternoon.  
Both were Tillamook boys, Coffman being the son of G. W. Coffman, and was about 18 years of age, while Ward was 16 years of age and was the son of H. A. Ward, who removed to Astoria from this county a few months since. Both were stout, strong boys.

It seems as though Governor Geer has Tillamook county's five votes already secured fixed in his vest pocket. Don't be too sure, governor, for there is something in common with this county and Multnomah, for they have both broken away from the Simon yoke. It is not out of place to ask what promise Joe Simon made to the governor if he would veto the Portland city charter bill? However that may be, Geer has made a good governor and the western and southern counties appear to want him re-nominated.  
In withdrawing their names from the political fight when they saw that their faction was hopelessly defeated, Messrs. M. F. Leach and Arthur Stillwell acted honorably and in a gentlemanly manner. But, boys, you'll have to quit that faction if you ever expect to get public office in Tillamook in the future, for it is plain that a revolution has taken place in this county and the old regime is no longer a potent factor in politics. Those who disagree with us are at liberty to run up against it as Leach and Stillwell did, only to find out they were wiser after the first skirmish than they were before. Consequently they honorably retired before they actually got into a good political scrimmage.
