General News of Interest.

Careful computation gives the strength of the scattered Boer commandoes at between 8000 and 9000 men.

Governor Geer's probable candidacy for the United States Senate will soon be the chief topic for discussion in political circles in Oregon.

Senator Simon appeared in the Senate chamber on Tuesday, after an absence of some weeks at home. He does not care to discuss recent political events in Oregon.

A terrific blizzard prevailed furiously over Central Wisconsin on Monday. It has been snowing and blowing all day and is very cold. It is the worst storm of the winter.

Storm warnings were displayed on Monday on the Pacific Coast from the Columbia River to the Straits of Juan de Fuca, and on the Atlantic and Gulf Coasts from Hatteras to Mobile.

Casper Kruger, the eldest son of President Kruger, and 24 other relatives of Mr. Kruger bearing the same family name, are among those who have recently taken the oath of allegiance to Great Britain.

A Portland man has an idea that he can rival or excel Santos-Dumont with his airship, but as he estimates that the first aerial machine will cost \$50,000, we will scarcely see it doing overhead business very soon.

The will of Cecil Rhodes provides for the establishment of colonial scholarships, as previously announced, and two American scholarships to each of the present states and territories of the United States.

The largest single order for American canned meats ever given has been received from the British government. When it comes to buying food supplies vast quantities for speedy delivery Europe is forced to come to this side of the Atlantic.

A remarkable and difficult surgical operation has been performed on Mrs. Frank C. Mehan, of New York. Eight inches of her backbone was taken out to permit the removal of a tumor that pressed upon the spinal cord. It is expected she will recover entirely.

The dairy products of the United States are due to pay of the national debt in a little over two years. The cow and the hen have performed wonders in the west in lifting farm mortgages and if Uncle Sam even gets into a tight place he might call on them.

Telegrams and letters of congratulation are pouring in upon W. J. Furnish, particularly from Eastern Oregon, almost every town and hamlet giving evidence that his nomination has aroused the greatest enthusiasm in that part of the state, with which he has been more particularly identified and where he is personally well known.

Considerable interest was manifested in the city election at Woodburn, Ore., on Tuesday, which passed off quietly. 222 votes being polled. The contest was between the "Good Citizenship," or anti-license people, and the "City," or saloon advocates. The result was in favor of the Good Citizenship ticket with the exception of recorder. Saloon license was voted down by 26 majority.

The Columbia River Fishermen's Protective Union, fixed the price of salmon for the coming season as follows: Six cents per pound for fish weighing 25 pounds or over, and 5 1/2 cents for smaller fish. No price for steelheads or bluebacks was mentioned. These prices are slightly lower than were named a year ago, when the rate was 6 cents for all classes of chinooks, and it is thought they will be satisfactory to the packers.

From the Pacific Ocean to the Idaho line and from the California line to the Columbia River, the Democratic County Conventions are instructing their delegates to the Democratic State Convention to support George E. Chamberlain for Governor. Chamberlain probably will be nominated to lead the Democratic state ticket by acclamation. It is one of the few cases where the officer is seeking the man. Against Chamberlain no one has appeared.

April 8, Governor Dockery's attention was called today to the alleged British war supply camp at Lathrop, Mo. The Governor said he knew nothing about the operations of the British more than that a market has been opened at Lathrop by private individuals for the past ten years. He says it is the largest horse and mule market in the world, and that it supplies the United States Government as well as the British Government with horses and mules.

The exploring expedition of Captain J. E. Bernier will sail from Vancouver, B.C., this year. Captain Bernier says he expects to reach the North Pole in 1906. He has just returned from England, where he was much encouraged by promises of aid. He will ask the Federal Government to vote \$60,000, and as soon as this sum shall be voted, he will purchase his boat. He expects to receive an additional sum of \$75,000 by popular subscription for the equipment of the expedition.

In asking leave to file a bill against the railroad merger, Attorney-General Stratton, of the State of Washington, presented to the Supreme Court a copy of the bill he proposed to file, and it was discussed by him and opposing counsel. This bill differs from that filed by the State of Minnesota in that it makes the Great Northern Railway Company, as well as the Northern Pacific Railway Company, defendants to the proceeding.

The remains of a man and woman were discovered in the railroad depot at Gilroy, Cal., when a box, which had lain in the depot for 10 years, was opened. There were no marks by which the remains can be identified. The box was left with the station agent by a rancher named Jamison, who told the agent that he would send for it. The rancher disappeared shortly after, and nothing has been heard of him since. It is presumed that a double murder was committed.

Because he did not receive the nomination on the Republican ticket for County Commissioner, Carl Johnson, a well-known resident of the town of Seaside, became a raving maniac, and is now in the custody of Sheriff Linville. The unfortunate man brooded so much over his failure to receive the nomination that his reason suddenly left him. Rather than have him committed to the state insane asylum, Sheriff Linville and other county officials decided to keep him at the county jail for a time, and Johnson's improved condition has demonstrated the wisdom of the action.

This is the time to bone your Congressmen for seeds. There are about 20,000,000 packages, more or less, going out in the mails free of postage, and everybody can have them for the asking. They are designed to jolly along the voter in the rural community, but the dwellers in the metropolis can get them just the same. There are flower seeds as well as vegetable seeds, and all are just as good as can be purchased from the seedsmen. Many Congressmen are puzzled to know to whom to send their supply, especially city Congressmen, and constituents will do a favor by wiring or writing their address and request.

New York's Dry Sunday. New York, April 6.—The police and the liquor men gave Greater New York a "dry" Sunday today. They sought there were degrees of dryness, so to speak, in different sections of the metropolis, the day has had no equal in the suspension of the liquor traffic since five years ago, when Superintendent Thomas F. Byrnes closed the saloons one memorable Sunday. Persons seeking spirituous refreshment then were compelled to resort to places outside of Chief Brynes' sphere of influence. His task, however, is said to have been easier than that confronted by the police today, for he had no saloon hotels with their sandwiches to contend with. These hotels must be taken into consideration, therefore, when the word "dry" is used in connection with these events of today, for the man who had money to buy a sandwich and a drink had small difficulty in satisfying his thirst. Few liquor dealers had the temerity to keep open and serve drinks alone, and of those who did, a majority were invited to the nearest police station, there to remain until bondsmen appear.

Unquestionably the driest part of New York to day was the "second platoon" of police made so many arrests. This is known as the west Thirty-seventh police precinct. Only one alleged violator of the excise laws was found today by the lynx-eye officers. Only two or three Raines law hotels opened their doors and the proprietors say that the law was closely observed.

Chinese Exclusion Bill Passed. WASHINGTON, April 7.—The House today passed the Chinese exclusion bill, after incorporating in it several amendments which increased the drastic character of the measure. The principal one not only excludes Chinese by birth and descent, but all Chinese of mixed blood. The chief struggle was over an amendment to prohibit the employment of Chinese sailors on American ships. An amendment covering this proposal was ruled out on a point of order, but subsequently was modified to evade the ruling and was adopted, 100 to 74.

As passed the bill practically re-enacts all the existing exclusion laws, and incorporates with them the existing treaty regulations. It extends these exclusion laws to the Philippines and the other possessions of the United States, and forbids Chinese labor in our colonial possessions coming into this country. The Philippine Commission, by the terms of the bill, is directed to adopt proper measures for the enforcement of the provisions of the bill in the Philippines.

Beet Pulp for Cattle. LA GRANDE, Or., April 7.—Charles K. Reason, of Ontario, is feeding 530 head of steers in the yards of the Oregon Sugar Company here. All but about 30 have now learned to like the beet pulp. All are rapidly taking on flesh. The steers eat about 30 tons of pulp per day. They are allowed all the straw they will eat, and have access to salt and running water. At first much hay and grain was fed. About 100 tons of hay has been fed here, and about 8000 tons of pulp.

Much pulp has been sold to Valley City, has fed 500 tons. Four carloads were shipped to Baker City, but none is allowed to go out now, as what remains will be needed in the yards. Mr. Reason will begin shipping beef April 20. In previous years it is said that cattle fattened on pulp made sweeter and tender beef than is obtained by other feeding. From 100 to 120 pounds per head is fed to each animal. The cattle here are nearly all high-grade Shorthorns and Herefords, and when ready for shipment will average about 1350 pounds each.

SPRUCE.

Mr. Peter Amacher considers himself quite fortunate for being in the land of the living, and threatens to sell his black cow the first opportunity—he has had a general dislike to her for some time, but it was not until Thursday evening of last week that she overpowered his temper completely, and endangered his eyesight by taking advantage of his helpless condition. He is not afraid of her provided that he has the pitchfork handy. He had driven her into the barn, succeeded in getting the rope around her neck and had gotten all through milking her, when just at that critical moment, not being able to defend himself, both hands being engaged, one with the pail the other with the stool, and in attempting to get up, she viciously attacked him, without any warning, by beating him in the eye with the bushy end of her tail.

Patrick to Die May 5.

New York, April 7.—Albert T. Patrick, who was convicted on March 26 of the murder of William Marsh Rice, was sentenced today by Recorder Goff to be put to death in the electric chair at Sing Sing prison on May 5. Rice died in this city on September 23, 1900. An appeal to be made to the Court of Appeals by Patrick's counsel will result in a stay of execution, pending a decision by the higher court.

The Recorder, in pronouncing sentence, made no comment on the jury's verdict. To the customary question as to whether the defendant had anything to say by judgment should not be pronounced. Mr. House, Patrick's chief counsel, said he desired to make a motion for a new trial and gave several reasons for the motion.

The Recorder denied the motion for a new trial. Mr. House took an exception and moved for an arrest of judgement. This was denied, and sentence was then pronounced by the Recorder.

Patrick was taken to Sing Sing in a train which left here at 1:05 P. M. His wife, who was Mrs. Addie M. Francis, was a passenger on the train.

Osmining was reached at 4:20 P. M. Before entering the carriage which was to take him to the prison, Patrick kissed his wife and said good by. At the prison he was shaved off and he was placed in a cell in the death house. He will not be required to wear the prison uniform while he remains at Sing Sing.
