Comment on the Institute Lectures.

It would have been a good thing had every young man and young woman in Tillamook heard Prof. Torbet's lecture on Monday evening, for anything that will create a spirit of ambition, perseverance and determination in the minds of young people is a good thing. The professor showed that it was not circumstances, poverty, birth or environments which kept persons from rising to places of distinction, for all had been endowed with a certain amount of brains, and he advised his hearers to use their brains and obtain a good education. That is Prof. Torbet's advice, and it is sound advice. Every community appears to have a number of young people who are without the least ambition, and who are content to sponge on others for a livelihood or are kept in idleness by their parents. The Headlight can say without fear of contradiction that it is from this class where the great army of tramps, dead beats and bums receive its recruits, and if teachers' institutes can be made instrumental in creating a spirit of ambition in young people, especially in those who are prone to be indolent, they are doing good work in many ways.

There is one thing about Prof. J. H. Ackerman, state superintendent of public instruction, that is highly commendable and appreciated, and that is he is not only progressive and aggressive, but he is up-to-date, something which is necessary in school work. New devices and machinery have turned the industrial world upside down, and the same can be applied to education. Mr. Ackerman's remarks on Tuesday evening were listened to with rapt attention, and a few things which he advanced deserve favorable comment. First is the uniform course of instruction in the public schools all over the state, and we are glad to hear from the lips of the state superintendent that the system was working admirably. Mr. Ackerman emphasized the necessity of a school library, and in doing so called attention to an act which was passed at the last session of the state legislature which left it to the discretion of the county court to levy a small tax for that purpose, and to show how small it would be, Mr. Ackerman said that all it would amount to in Tillamook county was the sum of \$187, and although he said it may mean but one dollar to some districts, yet for all that a few good books in each district school were of inestimable value, so he hoped the people would ask the county court next January to levy that tax. Then he took up the question of county high schools, and perhaps the most pointed remark made in that connection was when he reiterated this remark: "A boy at 14 years of age is not a proper person to leave home." All will acknowledge the logic of this, and he pointed out that the cost of sending three persons outside to obtain high school instruction would pay for a high school teacher in the county. Another experiment is to be tried, which is proving successful in the Middle West and other states, and that is to centralize school districts. In this way Mr. Ackerman claims that districts which have now from four to six months school will have nine months and become a graded school. A bill is to be introduced in the next state legislature for a number of convenient districts to consolidate, and the most central district would be where the school would be located. So as to enable the children in the other districts to get to the central school, conveyances would have to be provided to take them to school in the morning and bring them home in the evening. That is how it is arranged, and from from information we have at hand it is working satisfactory where the experiment has been tried. We do not know whether J. P. Morgan obtained his ideas from this, but it is the "community of interest" plan by which he is turning the industrial world upside down, with this difference probably, he is getting fabulous sums of money for consolidating the "community of interest" plan, while those who endeavor to apply it to the public schools will have the satisfaction of being dubbed a born crank and endowed with more cranky notions than common sense. However that may be, if the "community of interest" plan will improve the rural districts schools, giving then nine months teaching and a graded school at no extra cost to the taxpayers, why, by all means, let the people of Oregon be wide awake to bestow this advantage upon school children in rural districts. Before we close we must relate one little incident Mr. Ackerman told about to show, presumably, what some people expect poorly paid teachers to do. He said he came across a man who had charge of three horses, and for training these animals he received a salary of \$125 a month, while in a school house not far distant there was a trainer who had 30 little "animals" to instruct and who was paid only \$25 a month for his services. We must congratulate Mr. Ackerman on his lecture, and the only kick we have against him is he made us coincide with everything he said and left us nothing to criticize adversely, although some few years ago the professor and the editor had some friendly difference of opinion.

Oregon, from all accounts, as well as all parts of the Northwest, is in a fairly prosperous condition this year. Labor commands good wages and the products of the farm bring good prices. Tillamook county is always prosperous, and as some of the cheese factories report 26c. per pound net for butterfat for their May returns, the dairymen are happy and contented with that state of affairs. It is to be noticed this summer in Tillamook is the scarcity of people looking for new locations. Being somewhat isolated, we suppose other parts of the state attract the new comers now that condition are prosperous on the outside.

Rev. J. R. Welch, a young Presbyterian minister, has been stationed at Woods to look after the lost sheep and gather them into the fold. The influence exerted by a church in a community is not generally appreciated, but we hope Mr. Welch will succeed in getting up enough interest in this matter to get a good substantial church organization here, and build a church when necessary.—Ocean Wave. The Headlight thought previous to the election there were a number of politically "lost sheep" in and around the Ocean Wave office, so we hope that Bro. Weatherly will set the pace and allow himself to be "gathered into the fold," for he must feel like one ostracized from the democratic fold.

R. M. Watson, better known in Tillamook as the silly little, little silly man, has started another newspaper at Elma, Wash. What is Tillamook's gain is Elma's loss, for having bled his friends in this city and county on the blow hard and belly aching plan, it became unbearable, because the very people who nursed him most fondly they could not trust him. When the time came to show his gratitude to those who had helped him in his financial difficulties, he was heart and soul with those who were opposing those who had befriended him. That was the kind of gratitude Watson

returned for the political patronage he received at the hands of his republican friends. And they have good reason to feel disgusted with him, for it was almost impossible to tell which side of the fence he was to be found. Watson's indolence, cussedness, Southern bombast and laziness, gambling and saloon bun tendencies, made him a man totally unfit to be a mouler of public opinion.
