So as to make it discretionary with county courts as to appointing "ornamental" roadmasters, Representative B. L. Eddy, has introduced a bill to amend section 4853 of the code. The only change is that Cotny Commissioners or the County Court are authorized, at their discretion, at the first regular session after the approval of this act, to appoint one or more competent persons to take charge of the roadwork, whose term of office shall expire at the first regular session of the County Court in 1904, at which time the County Clerk may make an appointment for one year.

Petitions are being circulated for a county road on the Thayer tract across the Trask river. Every effort should be made to give settlers good roads, and as the County Court is showing a lively interest in this respect, in the next few years we predict that many new roads will be opened and the ones we have will be greatly improved. "With a little patience by those who are advocating better roads for Tillamook and by the districts assisting the County Court in every possible manner, much can and will be accomplished. The road question is a matter which is of much importance to every dairyman and the development of the county.

There was a good attendance of those interested in forming an athletic club at the city hall on Wednesday evening. The first business was to accept and adopt the committee's report on by-laws, which made it a permanent organization, when the following officers were elected for 1903: President, Thos. Coates; vice-president, C. Ben Riesland; secretary, H. Edmunds; treasurer, Claude Thayer. The name of the organization is the Tillamook Athletic Club, and the board of governors consists of the following gentlemen: C. W. Talmage, Claude Thayer, Thos. Coates, B. Ben Riesland, C. E. Hadley, H. Crenshaw, A. J. Cohn, H. Edmunds, Oak Nolan, Chester Holden, Fred C. Baker, F. Richardson, T. B. Handley, sr., C. I. Clough and B. C. Lamb. Already 85 persons have become members of the club.

Died, on Monday, at his home near Bay City, Fred Ducham, aged 40 years. Deceased had been in poor health for several months, and the past few weeks all hope of his recovery was given up. He was tenderly nursed by his wife, friends and members of Star lodge during his long sickness. Last October he met with an accident, when a pile driver fell and injured him. After that he was taken down with typhoid fever, and since then gradually declined in health. Deceased was well known in the county, having been here 12 years. He married a daughter of Mr. and Mrs. Frank Worthington, and two children, a boy and a girl were born of the union, who survive him. Funeral service took place Wednesday at the residence, being conducted by Rev. Father McDevitt, who delivered an appropriate address, after which the Workmen took charge of the funeral and conveyed the remains, followed by the sorrowing family and sympathizing friends, to the Bay View cemetery, where the ritual of that order was read and the remains consigned to the silent city of the dead. About two years ago Ducham became a member of Star Lodge, A.O.U.W., taking out a beneficiary certificate for \$1000, which will be paid his widow next month.

Sir—Your letter of January 22, 1903, regarding necessity for work in Hoquart Slough and Tillamook Bay, is received.

I am sorry to hear that the channels there are giving difficulty as our reports have not shown that there was much, if any, trouble in the steamers getting in and out.

It is my intention to take up this work at the earliest opportunity and I hope soon to have a man available to send there to take charge of it.

The office has been crowded with work since the river and harbor bill and I was under the impression from the reports that Tillamook was getting along finely with the channel as already dredged under Captain Harts.

I will use every endeavor to push the work and trust that you will be a little patient in the case if I cannot get around quite as fast as you would like.

Editorial Snap Shots.

It is still an open question who will be elected United States senator and congressman for the first district.

Some men live in luxury at the hotels in this city and talk about their "friends," but what about their wives and children they have deserted and left to scratch for themselves?

There is some little complaint on account of the raise in the price of lumber. But considering everything, will lumber ever be cheaper—even if there is another mill started—and is there not a probability of it going much higher? It took another jump in Portland last week.

It looks as though the Willamette Valley is competing with Tillamook for the honor of having the largest amount of rainfall this year, for 3.51 inches was reported in 24 hours at Eugene on Saturday, which caused a flood. But Tillamook holds the broom for rainfall.

Everything looks favorable for another good year for Tillamook. With renewed activity in milling, an increase in the dairy output, the demand for dairy ranches and timber claims at advanced prices, and the air of contentment, industry and prosperity which have characterized Tillamook county for the past few years, all go to prove that the business outlook for this year never looked brighter. And without any prospect of the Portland, Nehalem & Tillamook railroad being built either.

The department stores in London have adopted a novel method in dealing with female kleptomaniacs of gentle birth, for every woman detected in the act of shop lifting is given her option of being prosecuted in court or being birched by the managers, a person specially selected for her birchings. It is reported that in one department store 20 women have accepted the ordeal of birching. If logs are so scarce and bring \$8 and \$10 a thousand on the Columbia river, with a ready sale at Astoria and other points, why wouldn't it be a profitable undertaking to make up several rafts of logs in Tillamook Bay and have them towed to the Columbia river during the fine weather the coming summer? We simply offer this for what it is worth, but believe there are men with skill and ingenuity enough in Tillamook who could make a success of it if they undertook to go into that business. Not that we want to see logs go out that way, but as logs fetch double the money on the Columbia as they do in Tillamook, it seems that the difference in price offers strong inducements to get into a market where the price for logs range high.

To our way of thinking it looks like bad taste and poor judgment, because members of the Port of Tillamook Commission have different ideas as to modes of procedure to air the "family linen" of trivial, yet pleasant affairs to some, in the Portland papers. Portland has had a disgruntled member on its commission who thought he knew everything and wanted to be the whole thing, but the

majority of that commission thought and voted different, whereupon Mr. Commissioner, not willing to abide by the vote of the majority, commenced airing the "family linen" in the press. We hope for better things from the Port of Tillamook Commission. This is the absurd, out of place, and even opinionated, ideas sent by the Evening Telegram's correspondent in this city to that news paper:

"Mayor Talmage has appointed three members to fill expired places on the Port of Tillamook Commission. As these appointees have to be approved by the Commission, their names have not been made public. These appointments caused some discussion, as many people thought that the commission was dead or quashed. This commission consists of nine members, who, in the words of an old settler, 'Do nothing but give a banquet once in awhile; present the inspector with a flag; pass a few resolutions and get their names in the paper. It's dollars to doughnut,' he continued, 'that not four out of the nine commissioners have been down the bay since the commission was created. There seems to me to be some Ellis G's on this commission, and I don't believe there has been a full attendance at any of the meetings held, and these have been scarce enough.' However, the commission is in existence and is composed of good, substantial men, who, at some time, may do good work for the Port of Tillamook."

Every person in Tillamook, after reading the above will say that looks like giving the commission a smack in the face and at the same time a pat on the back.

We would suggest to Brother Baker of the Tillamook Headlight that should he have occasion to visit North Yamhill again, he will find a hotel here second to none in the state, and in which he can eat a first-class meal, sleep in a first-class bed, have a bath and get a shave and hair cut. It will not now be necessary for him to go to the livery stables or the butcher shop to arrange his toilet.

That is certainly good news to Bro. Baker, the people of Tillamook and the traveling public. Rah! rah! rah!—rah! North Yamhill has a new, up-to-date hostelry, the best in the state, where Tillamook people, who are used to all the comforts and luxuries of life, can now be entertained as white people should be. And Bro. Baker will have no longer any occasion, when he visits North Yamhill, to debate within his mind which was considered most etiquette in that burg to change his duds on the sidewalk or in the livery barn, but because we had to decide on either one of these alternatives, we hope the Record man won't make it a stereotyped joke against us.
