

Hermann is the Man.

HERMANN, Ore., April 9.—Binger Hermann was nominated for Congress to-night. The convention was in session 9 1/2 hours, and was in tumult most of that time. Early in the convention Hermann hovered within six or seven votes of the 87 required to nominate. Then his forces went to pieces in the face of stubborn opposition. His rivals succeeded to the mastery of the convention, but they could not agree upon a candidate. For four hours each of them refused to yield.

The Hermann managers took heart again about 10 p.m. and reorganized their ranks as they had been early in the convention. Thereupon Eddy, of Tillamook declared that his delegation of five, in order to end a fruitless contest, would support Hermann. Vawter withdrew and left his delegation to go whither they desired, and his people flocked to Hermann. Gatch of Marion and Kelly of Linn united their forces. The union was too long put off, however, and accomplished nothing.

The final vote was: Hermann, 95; Gatch, 72; Kelly, 9. The total number of votes cast was 176, three more than were in the convention, but the opponents of Hermann saw that they could accomplish nothing by demanding another ballot, and on motion of Kay of Marion, Hermann was declared the unanimous choice of the convention. Speechmaking by Hermann and his rivals showed that the outcome of the fight had not left wide breaches, and that all elements of the party would work for the election of the party's nominee.

Hermann's rivals had beaten all hope out of his supporters. About 7 p.m., Brownell, who had been elected chairman of the convention by combined Hermann and Clackamas votes, withdrew and went to bed, charging the members of his delegation with treachery for failing to aid Hermann toward the nomination. Hermann himself went to his hotel in the belief that his game was lost. About 11 o'clock both learned that the convention was coming back to Hermann, and they returned to the convention.

At 11:25 o'clock the last vote of the 24th and final ballot was counted and Hermann was nominated.

While the convention was still cheering over the victory, Mr. Hermann entered the hall and worked his way through the crowd to the chairman's desk. Here he was introduced to the assemblage by Chairman Brownell.

How the Fort was Taken.

MANILA, April 11.—The investment of Bacolod, Island of Mindanao, which was captured by Captain Pershing's forces after a fight in which 100 Moros were killed, occupied three days. The final assault was made at noon, Wednesday. Desperate fighting took place inside the forts. Seven cannons were captured, and 1 Americans (not three, as previously stated) were wounded, a few of them seriously. It is probable that all the Americans will recover.

The column approached Bacolod early on Monday, and found new forts which had been a year under construction, lying battlements. The Moros did not wait to be attacked, but fired a volley, which wounded two Americans. Captain Pershing then decided to bombard the fortifications, and McNair's and Gattcy's batteries took up positions and shelled the forts and works until Wednesday morning, the infantry and cavalry supporting the attack. Many of the Moros left the forts on Monday and Tuesday nights and escaped in boats.

The assault on Wednesday was carefully prepared. The column carried forward a bamboo bridge, on which all the troops crossed the moat under fire, and afterward sealed the walls. The fighting inside the fort was most desperate. Sixty dead Moros were found beside the walls, and 40 were killed in the trenches.

The whereabouts of the Sultan of Bacolod is not known. He is believed to have escaped Monday night.

Major-General Davis reached Pantar, North Lanao, yesterday. He is in communication with Captain Pershing, and has forwarded supplies to Maharis, which is the destination of Pershing's column.

Western Agriculture.

The past few years of western agriculture have been a very satisfactory nature and the promise for the coming year is to the highest degree satisfactory. Looking to the past the agricultural producers of the west have the amplest reasons for thankfulness. The years have been filled with the most abundant harvests and the best prices have prevailed for all the crops. There has never been a time in the history of the country when the average of farm products commanded better prices than during the last three or four years, or when they had a better market or better prices than they are receiving today. This is one of the considerations that needs to be thought of in estimating the general value or the home market. The common notion is to regard the value of our home products according to the exports, but this is a mistake. The real value of these products is to be determined by the domestic commerce in them, which is many times more than the foreign trade.

The great bulk of the agricultural trade of the west is not in foreign lands, but in our own country. While the producers of the west send many millions of their products abroad, they sell of those products at home hundreds of millions more than are shipped out of the country and at better prices than they receive for foreign shipments. It is thus a matter of the utmost importance to our producers that they should preserve the home market for themselves.

Western agriculture is today the substantial fact in the national prosperity. Without it nothing else can be of endurance. It is the mainstay of national prosperity. Fortunately the outlook for it is most satisfactory.

General News.

The quartermasters of Portland, Seattle and San Francisco have been directed to advertise for bids for 10,000,000 feet of lumber for shipment to the Philippines. Included in the contract will be 2500 doors.

The Kansas Utopian Association is an illegal organization, says the Supreme Court in a decision handed down in an appeal case of a lodgekeeper from Brown County. "Stripped of its subterfuge and pretense, it is simply a whiskey saloon." This closes over 200 lodges, with 65,000 members.

A dispatch from Trenton, N. J., says: Governor Franklin Murphy's annual proclamation, forcibly dissolving those trusts and corporations organized under the law of the state, which have not paid annual tax, has been sent to the printers. Nine hundred and twenty-seven concerns, capitalized in the aggregate at \$239,000,000 are affected.

Announcement of the successful trials of the submarine boats Pike and Grampus at San Francisco were received at the Navy Department from Captain W. H. Whiting. Above the water the Grampus made a speed of 8.45 knots, and submerged 7.3 knots. The Pike's speed above water was 8.51 and submerged 7.18. In the torpedo firing the records were: The Grampus at 7.26 knots made a center hit, and the Pike at 7.14 knots missed the target, but pointed fair for it.

Brigham Young, president of the Council of Twelve Apostles of the Mormon Church, died in Salt Lake, after a lingering illness. Apostle Young was the second son and fourth child of the late President Brigham Young, and was born, with a twin sister, Mary Ann, December 18, 1836, at Kirtland, O. His mother was Mary Ann Angell Young, second wife of the first Brigham. His father was a widower with two little girls when he married Miss Angell, and she took care of the little girls.

Crown Princess Louise of Saxony who eloped on December 11 with Andre Giron, the tutor of her children, and her husband, the Crown Prince of Saxony, are to be reunited next week, according to a despatch from Berlin, says the Paris correspondent of the World. The reconciliation is to be effected for the sake of their children. It is announced that the Crown Prince will visit the Crown Princess at Salsbourg next week and they will immediately be remarried. It is reported that they have agreed to their course and have pledged each other not to refer to the past. A despatch from Salsbourg confirms the above, stating the reconciliation is complete.

Attorney-General Hamlin certified to State's Attorney Dineen, of Cook County, Ill. the names of 3000 corporations which have failed to comply with the provision of the Illinois anti-trust act, recently upheld by the Supreme Court, requiring an annual affidavit to the effect that the corporations have not entered into a pool, trust or combine. Accompanying the list of names is a letter of instruction from the Attorney-General requesting the State's Attorney to proceed according to the provisions of the anti-trust act. The act of the Attorney-General will be followed by the furnishing of lists of delinquent corporations and recovery the penalty provided by law. The penalty fixed by statute is \$50 per day, and, as these corporations have been delinquent for five or six months, they are each liable to a fine of \$5000 or \$10,000.
