The Kansas legislature adjourned without making any direct appropriation to the flood sufferers. The county commissioners of the various counties are authorized to aid the sufferers in their own counties to any extent and special legislation was enacted to enable the counties to replace bridges by issuing county bonds.

Santos Dumont has completed another airship. He ascended at Paris and went where he wanted up and down some of the principal streets. This is the smallest airship that he has constructed and is propelled by an engine of three horse power. It answered to the helm perfectly and when ready to descend he came down at his own door.

George W. Vanderbilt has purchased a large tract of land in North Carolina and will build a model manufacturing town, which will be completed and ready for occupancy before any work is done in the factories. A complete system of water works, electric lighting, heat and power will be installed. It is contemplated to make it better than any manufacturing city in existence in the modern conveniences of life.

The Mormons are beginning to divide up into sects. Some time ago a large body of Swedes broke away from the mother church; now 600 Mormons of both sexes are threatened with excommunication if they do not quit dancing. If we remember rightly, Brigham Young encouraged dancing and set the example by going on the floor and leading the dance. Perhaps the solution of Mormonism is in their breaking up into sects.

Says Charles S. Fairchild, who was secretary of the treasury during a large part of Cleveland's first administration: "I do not believe there is the least doubt about Roosevelt's election." Of course, there is not room for the least doubt on that point, but a leading Democrat who makes that concession may be deemed to be indiscreet. If that personage, too, as in ex-Secretary Fairchild's case, be a man who stands close to Cleveland, the indiscretion is all the more marked.

These little amenities at Kiel, in which William II. and some of the American naval officers figure, make pleasing reading to the American people. The kniser generally rises to a situation of this sort, as he did very gracefully in the present case. His message to President Roosevelt of praise for the American admiral and squadron was very well worded, and has been received in the spirit in which it was sent. The United States will have a chance to reciprocate when representatives of the German government come to the World's Fair in St. Louis in 1904.

Seldom does the second half of a calendar year open with such promise for the country as does that which begins this week. In New York city in the next few days \$147,000,000 will be distributed in dividends and interest by the big corporations centering there. A considerable addition will be made to this total by Boston, Philadelphia, Chicago, St. Louis and the other big centers. That \$147,000,000 which New York is to disburse is by far the largest sum which has ever been distributed at the beginning of a half year. The amount which was given out at the opening of January, six months ago, was \$138,000,000, which broke all records along to that time. It is to be presumed that the exhibits made by other business centers will also surpass all previous records by them. All this, however, has been ex-

pected, and its occurrence does not attract any especial attention.

A waterspout striking in the immediate vicinity of Oakford Park, Pa., caused a flood that has destroyed many lives and much property. It is known that some 20 people were killed, and so far many others have been reported missing. The dam at the head of the ravine in which Oakford Park is situated gave way under the impact of waters from the cloud-burst at 4 o'clock and swept down through a crowd of picnickers.

Sheriff Tell Taylor has in his custody at the County Jail Wallace and Olace, at Pendleton, Or., two small boys, aged 8 and 11, who are charged with attempted train-wrecking. The boys have been living in the country near Wallula with their father, their mother having died several years ago. The boys have had no training at all and a good part of the time have been left entirely alone for days at a time while the father was away at work. Lately the boys have been amusing themselves putting spikes, railroad bolts and nuts on the track to see the engine "buck." They say it was great fun and didn't know it was wrong. The company superintendent has been wondering for some time what caused the trouble at this point and at last set a man to watch, with the result that the boys were detected and have been put in the cage of Sheriff Taylor until some disposition can be made of them. They will probably be sent to the Boys' and Girls' Aid Society or the Reform School. They were quite a sight before they were taken to the barber and given a bath and hair-cut, as they looked more like animals than children.

SLAY MEN IN MOB.

Indiana Troops Fire on Rioters.

EVANSVILLE, Ind., July 6.—Following four days of rioting and general lawlessness, this city tonight saw the most terrible of its experiences with rioters. Seven persons are dead and 14 are known to be injured, and at least that number more are thought to be hurt. City Fireman Henry Cappler, buckshot charge in face and body wounds, serious, will die; Lee Hawley, laborer, shot in leg; Robert Miller shot in cheek, not serious; Charles Presky, aged 17, grocery boy, shot through left wrist and bullet wounds in both heels; Theodore Beem, aged 20, shot in right side, painful flesh wound; John Fares, aged 48, shot in head and hip, may die; Albert Kasuss, soldier, shot while picking up wounded rioter, hit in right arm, not seriously. Six other rioters were seen to fall, but got away before their names were learned.

Four members of Company A, First Regiment, suffered bullet and light gunshot wounds on the body. One of them was shot through the shoulder, another through the ankle, and the other received two slight scratches. The Deputy Sheriffs were slightly wounded.

Militia Fires on the Mob.

At 10:30 o'clock the members of Company A, First Regiment, Indiana National Guard, after a day's vigilant guarding of the County Jail, and 100 Deputy Sheriffs, under Sheriff Chris Kratz, fired point blank into a mob of 100 men gathered on Fourth, Division and Vine streets, surrounding the Vanderburg County Jail, and attempting its capture. From 7 o'clock this morning until the hour of tonight's catastrophe the crowd surged about the jail, calling the militiamen vile names, assaulting them with stones and berating the Deputy Sheriffs who guarded the jail. The mob had gradually become more and more excited, and its manifestations of uneasiness more frequent, and at 10 o'clock it was seen that nothing could prevent an assault on the jail.

At 10:30 o'clock the rioters pressed forward with determination, and innocent onlookers and the curious followed. Slowly they forced the militiamen back toward the jail, until the alleyway between Division street and the stone building was reached. Then the leaders, with a bicycle in their front as a shield to the bayonets of the soldiers, attempted to enter the alley and storm the alleyway entrance.

Soldiers Use Their Bayonets.

Captain Blum, of the National Guard, ordered a charge on the rioters. Gradually the crowd was forced back, the soldiers using their bayonets and butts of their guns. Suddenly a rioter fell. A soldier tried to drag him to his feet, but before he could do so was assaulted by a rioter. Stones and boulders began to fly through the air. A soldier was struck with a rock and fell. A rioter was knocked down with a gun butt and then a shot was fired. The one shot started a fusillade of musketry and shot-gun fire from the defenders of the jail, and a scattered return fire from the rioters. Fully 300 shots were fired from the jail windows, the Courthouse steps immediately opposite, and the soldiers in the streets. No one knows who fired the first shot. The soldiers say it was the rioters.

Governor Durbin is said to have instructed the authorities not to jeopardize the safety of the jail with half-way measures. The soldiers and deputies fired into the retreating mob of men, who ran into Division street. For 15 minutes the firing continued. When it ceased, the soldiers had the place. In front of the staggering band of 58 soldiers lay the dead and wounded. Moans and shrieks of agony and fear came from the injured.
