### The Land Agent.

We have received a copy of The Land Agent, published by C. Ben Riesland in Portland. It was nicely gotten up from a mechanical point of view, and as an advertising venture looks as though it was a financial success. The literary production is disappointing, for it deals with sarcastic personalities and insinuations against some of our citizens which are pretty rank, for instance:  
 "It has, of course, been the lot of this, as well as of all other new countries, to foster in its bosom despots, who wish to rule with a hand of iron. If a deal were made, by fair means or foul—mostly foul—they must get the largest plum in the basket, or they would, like any other dragon, spit fire, and try to make things miserable for those who attend to their own business and prosper."  
 "Now, you may have some cut-throat of a real estate man in mind—I know I am thinking of one at this minute who would steal the crust out of the mouth of a starving child—but that doesn't condemn all of us."  
 "Some of the methods that have been resorted to during my sojourn in Tillamook County are of such a nature that fair-minded men will support me when I say that they savor very strongly of outrage."  
 "A house divided against itself cannot stand; a country of internal strife cannot prosper. I know that it is the policy of a certain class of men in this County to 'sit down on' every enterprise that does not directly fill their own pockets and I wish to state further that it is the duty of every good citizen to fight such individuals with the contempt that is ever due cowardly envy and malicious greed."  
 "The Jay Lawyer" and "The World's Prayer" personal insinuations, and the roasting of the Tillamook Driving Association came in for, instead of inspiring persons to come to Tillamook, will convey the impression that this county is a devil of a place and in the hands of cut-throats and people who make it a point to fleece everybody that came here. Literary matter of that character in such an edition is altogether out of place and not conducive to bringing new settlers here. The whole of the descriptive matter is written in a general way and does not contain any features which are persuasive or attractive to arouse the curiosity of those who are seeking new homes. It is plain to see that The Land Agent was published for three things: An advertising scheme for the money there was in it, to roast some of our citizens and to boom the editor's own business. These are the salient features of the edition, and we can commend C. Ben Riesland for the success he has made in that respect. And we hope the advertiser will be satisfied.

### Editorial Snap Shots.

Say, C. Ben, who's the jay lawyer and the world's prayer?  
 Bay City ought to be on the anxious seat about bonding the railroad.  
 The editor of the Headlight was not aware that Tillamook was a cowboy country until he saw the cover of The Land Agent. But then, perhaps, it's intended for cowboy real estate men trying to lasoo one another.  
 After all said and done, the Headlight is the best and cheapest advertising medium, for it goes weekly into the homes of the people our merchants want to do business with. Trade with the business men who advertise in the Headlight, for they are reliable and will give you a fair and square deal, something that you cannot get from peddlers and rooustabouts.  
 Oh, no, the editor of the Headlight has never aspired to be a member of the Port of Tillamook Commission or any other public office since he has been in Tillamook, and anyone making such a statement is misleading the public by false statements. In a public way we are content to be the editor of the Headlight, for every week we command the attention and ear of a large proportion of the people of this county.  
 A petition was circulated this week asking the property owners to grant and to do all they can to assist in getting a right of way for the Portland, Nehalem & Tillamook Railroad Company. We hope those who have taken the matter in hand to get a free right of way will succeed, but we have grave doubts about it unless they take along a good big sack filled with \$20 gold pieces. Anyway, that is our experience in trying for a right of way, no matter how commendable the enterprise. It may be that Tillamook people are not built that way. And, another thing, it is not a positive fact that the syndicate will take the bonds.  
 Some of our business men have a just cause of complaint when they see dozens of peddlers, men who never pay taxes or do anything for the county, cutting into their trade and taking the business to other towns. They have a right to kick

and should kick hard until a heavy tax is put upon peddlers. But, say, we have also a kick at the business men of this city, whose interests the home newspaper have always championed. Why advertise in an advertising scheme that is printed in Portland and to boom business houses in that city so as to get "Mail orders" from Tillamook. It's too funny for anything how The Land Agent has worked our business men for advertisements for the purpose of advertising his own business, but as everything is fair in love and war and the real estate business, we will snicker and let it pay at that.
