

Ordinance No. 152.

An ordinance to prohibit minors from being or loitering on the streets and other places in Tillamook City during certain hours, and to repeal ordinance No. 82.

The people of Tillamook City do ordain as follows:

Section 1.—That no minor within the corporate limits of Tillamook City under the age of eighteen years shall be upon any street, alley or public place of the city on any night between the hours of 9:00 o'clock p.m. and 4:00 o'clock a.m. from May the 1st to September 30th, inclusive of each year, nor between the hours of 8:00 o'clock p.m. and 4:00 p.m. from October the 1st to April the 30th inclusive of each year, unless such minor be upon an errand or other legitimate business for his parents or guardian, but in no case during such time that such minor shall be upon such errand or other legitimate business shall he loiter upon any street, alley or other public place of said city.

Section 2.—Any person violating the provisions of this ordinance shall upon conviction thereof be punished by a fine of not less than two dollars and not more than ten dollars and in default of the payment of such fine shall be committed to the city jail one day for each dollar of such fine.

Section 3.—Ordinance No. 82 is hereby repealed.

Best the Indians.

CHEYENNE, Wyo., Nov. 2.—A battle with the Indians who were Sheriff Miller and Deputy Falkenberg Saturday, re-inforced by a large number of redskins who had been hunting in the vicinity of the scene of the fight, reported to have taken place to the west of the Horseshoe ranch. The fugitives were traced by a posse, and with their reinforcements made a determined stand. Nine Indians are reported killed and 10 captured. The white men were without loss or injury.

The news of the battles has spread to the reservation and to other Indian parties and a general uprising of the Indians is feared. There is reason to believe that Indian couriers are en route to the red men to deeds of violence. Governor Chatterton is investigating the report of the second battle, and should the story be confirmed he will immediately order troops into the field to suppress the Indian uprising.

Authentic advices from the scene of Saturday evening's bloody battle are that six Indians were killed, 10 wounded and five captured. Four made their escape. Twenty horses, 12 wagons and considerable game and Indian paraphernalia were also captured.
