A suit was filed in the circuit court last week against the Elmore Packing Company charging it with the crime of engaging in the business of packing salmon without first having obtained a license. The offence was committed in this county on the 11th September. This is the same case that W. W. Rifehalgh was arrested and tried for in Justice Alley's court and was acquitted, Rifehalgh having testified that he was only acting in the capacity of superintendent to the Elmore Packing Company and the fish were not packed but merely salted to keep them fresh until they reached Astoria. The Elmore Packing Company has since taken out a canning license, and may also take out a packer's license, and in that event it is probable the suit will be dropped.

George Brown, father of Mrs. A. C. Gist, died at Dallas on the 26th of last month after an illness extending over a period of twelve years, aged 80 years, 3 months and 9 days. He suffered a stroke of paralysis about 12 years ago, and he never fully recovered from its effect. The deceased was a native of Kentucky, and was born July 17, 1823. In his early youth, he moved with his parents to Indiana, and later went to Missouri, arriving in the latter state in 1831. In 1847 he crossed the plains to Oregon and settled in Polk county, where he resided continuously until the time of his death. He was married to Miss Martha Hines, of North Yamhill, in May, 1850, who had nine children. George Brown was a good citizen. He was honorable and upright in his dealings, and was respected by his neighbors for his unyielding loyalty to the principles of justice and right. He managed his business affairs well and accumulated a considerable amount of property, most of which was devoted among his children before his death.

Fatal Shooting Accident.
 A sad and fatal accident happened on Saturday afternoon on the Nehalem river, when Matt Olson accidentally shot his stepson, Carl Gilbert, a young man 17 years of age. They had rowed to the cannery from their home in a boat with salmon, and it was while returning that the accident happened. They had taken a gun along with them. Olson was in the bow of the boat and Gilbert was facing him, rowing the boat by pushing the oars, a practice common with fishermen. A band of ducks was seen overhead and Olson picked up the gun to have a shot, but as the ducks were out of range he did fire, placing the gun down in the boat again. In doing so, however, the gun suddenly discharged and Gilbert being in range, the contents passed through the upper part of the rubber boot on his right leg near the knee and then pierced Gilbert's right groin, tearing a hole in his flesh large enough to place a man's hand. The sudden discharge of the gun was a surprise to Olson, and inmediately after Gilbert exclaimed: "Papa, I'm shot!" Having obtained assistance, the injured young man was taken to Nehalem, but before reaching there he died from internal injuries, 12 to 15 minutes after the accident happened.
 Coroner Reynolds was notified and went to Nehalem and made an investigation, and after examining Olson and several witnesses concluded that the shooting was purely accidental, so decided not to hold an inquest.
 Olson is greatly distressed on account of the accident, for Gilbert and himself were on the most friendly terms, and as Gilbert was somewhat of a cripple Olson had shown a lively interest in the young man by helping him all he could, and it is on this account that Olson is doubly distressed. The entire family, including Gilbert's mother, is prostrated with grief.
 The funeral took place on Wednesday, the Rev. Wilfred Smith, pastor of the M.E. church, conducting the service, which was largely attended by neighbors and friends. The bereaved family has the sympathy of the entire community.

The Next City Election.
 The next city election in Tillamook City will be of more interest than here, before, for the taxpayers will be called upon to decide a question of public policy, that of voting to bond the city for \$60,000 for a new water system. It is not often that the citizens have an issue at the city election, but they have one this year where the lines will be sharply drawn. Instead of the usual city caucus those who want to bond the city for \$60,000 nominate a city ticket, and those who are opposed to bonding the city nominate another ticket from top to

bottom. No one should object to that, for it will give the voters an opportunity to express themselves in the ballot box. Although it would not be a correct criterion to go by, for only taxpayers are allowed to vote to bond the city, and for that reason there might be some objection to the suggestion of two tickets. Good arguments can be made for and against bonding the city, and on that account the opinions of those who differ one with another on this question should be respected. As we have stated before, it is now up to the taxpayers to decide one way or the other this long drawn out agitation for a new water system, and as the question of cost is no longer in doubt, for it will take \$6,000, if not more, to construct it, it now remains to be seen how the majority of the taxpayers will vote, or in other words will they enter into the spirit of the agitation to "go up" the present water company? It is pretty generally known that was the object of the first agitators for a new city water system, and which the taxpayers are called upon to endorse and at the same time vote a big bonded indebtedness for a little city to struggle under.
