Gamblers Leave Grant's Pass.

GRANT'S PASS, Or., Jan. 12.—Grant's Pass, the mining center of Southern Oregon, has been suddenly transformed from a wide open town, with all kinds of gambling devices running at full blast, to a closed town with not even a slot machine operating.

Last Thursday night at 8 o'clock games were in progress, but Friday morning everything in this line was stopped. Sunday, for the first time in several years, the saloons were closed—and no liquors were sold; even the "blind pigs" were headed off. The cause of the condition is the change of city administration. Mayor Gilkey took his seat Thursday night and from that minute Grant's Pass was a changed town. Gamblers and slot machines have been leaving town and one train relieved the city of 13 professional gamblers. One saloonman openly declared that he would keep his sitting room open Sunday, which he did, but early Monday morning he appeared before the Mayor asking that no charge be preferred against him and promised to be good. He was informed that two more violations would revoke his license.

Mayor Gilkey has the support of the City Council and public sentiment.

Pendleton a "Wide-Open" Town.

PENDLETON, Or., Jan. 11.—The new city administration, which is for an open town and which favors gambling, believes a revenue should be derived from the gamblers, and the officers have already started in to obtain that revenue.

Nine of the gamblers, those who own tables and gambling outfits, were arrested Saturday and each forfeited a \$150 bond. It is understood that such arrests are to be made every three months.

The town is now wide open, and gambling is being run on every side. Games of all kinds have been opened, and even the nickel-in-the-slot machines, stored away so long that they had rusted, are now rustling, eating money.

Gamblers of all kinds are coming into the town from Washington and from the Coeur d'Alenes, where several thousand dollars' worth of gambling property was burned recently.

TWAIN'S VOW OF SILENCE.

The Humorist Says He Will Make No More Speeches from the Public Platform.

Mark Twain has retired from the public platform for ever. His appearance at Missouri university, where he received his degree of LL. D., was his last as a public speaker. On this occasion he talked for nearly an hour. He was in a brilliant mood. There was a flash in every word he uttered, and he proved the truth of the assertion of Julian Hawthorne, that no man in the world can handle a joke for all it is worth and bring it out so forcibly and clearly as Mark Twain.

The audience laughed and laughed again, but some of them cried when the speaker said in tones that shook with suppressed emotion that he was bidding Missouri and old friends farewell forever.

"Please announce in the papers," said Twain, "that I have retired forever from the public platform." When interviewed concerning the recent dispatches to the effect that the German translations of his works have been excluded by the Russian authorities, Mark Twain was not a bit worried. "I am not in the least surprised," said the humorist. "The books of hundreds of other authors are excluded every year from Russia, and the fact that my works are barred gives me little concern. I am but one of a vast number whose books have been excluded and are being shut out every day by the Russian authorities and I take it as no special compliment that I am among so many."

"Russia has a great many Germans in its population and is gradually Russifying them, and naturally it does not wish any literature circulated that would influence any of the people in favor of a monarchy.

"In some of my works I may have said something that could have been colored into a pronounced expression of views against the Russian government, and it is probable that this accounts for the fact that my books have been barred, and I think that is the political east of some of my stories is all responsible."

TELLS OF FLOATING ISLANDS.

Steamer Returns to New York and Resonant Remarkable Experience in Caribbean Sea.

The Norwegian steamer Donald, from Banes, with fruit, has arrived at Philadelphia, and Capt. Warnecke tells this remarkable tale:

"We were two days out from Banes, and about 30 miles from Watlin's island, in the Caribbean sea, when we came upon a floating island. I, with the mate and several of the crew, rowed toward it. Thousands of little monkeys scampered all about the shore, and when we were in range they began a bombardment by shying coconuts at us. We captured two monkeys.

"The following day we discovered another floating island. This time we were greeted by a covey of parrots of most brilliant plumage."

Capt. Warnecke declared that the eruption in Martinique had shaken up the entire district, and the small pieces of land had become separated from some inhabited island.

TWENTY-STORY HOTEL.

Magnificent Structure to Be Erected at New York at a Cost of Ten Million Dollars.

Through the sale of the Plaza hotel property at Fifth avenue, Fifty-eighth and Fifty-ninth streets, New York city, to the George A. Fuller company and allied interests, there is to be erected on the site a new 20-story hotel which those interested in the enterprise say is to be the finest structure of its kind in the world. The price paid to the New York Life Insurance company for the property is \$3,000,000, and among transactions involving no element of trade it is believed that the purchase ran's as the largest in the city's real estate annals. Including the cost of the new hotel building the enterprise will involve nearly \$10,000,000. Associated with the George A. Fuller company in the purchase are the Central Realty, Bond and Trust company and Hallgarten & Co. Through the bankers, it is understood, considerable foreign capital will be interested in the project.

MARCONI HAS NEW RIVAL.

Wireless System of Telegraphy is Reported to Have Been Much Improved.

A new system of wireless telegraphy, which it is asserted is far superior to the Marconi system, will soon enable the public to send the messages as quickly as by wire telegraph. Initial station in New York city is in the Chestnut building, and on the top of the building the apparatus for sending and receiving messages have been installed. The system is of American invention, the work of E. H. Smythe, of Chicago, and Lee De Forest, a graduate of Yale university.

The system differs radically from that of Marconi, as messages can be sent and received as rapidly as the operator can work, the speed of 40 words a minute having already been attained. Distinct messages have been received over a distance of 75 miles.

Punishment or Reward. England wants Kruger to go back to South Africa and settle on a farm. Whether this is to be a sort of punishment, says the Chicago Record-Herald, or not, must depend upon the way one looks at farming.

Missouri Made a Superfluity Now. Missouri mule raisers, remarks the Chicago Record-Herald, will now have to hunt another market for their surplus stock.

NO POUND WEIGHTS IN TROY.

The Measure Exists Only in the School Books and Not in the Jewelers' Shops.

"Did it ever occur to you," said a college professor to a Chicago goldsmith, "that you have no such thing as a pound weight?"

It had; but the professor is willing to bet that not one graduate of a high school out of twenty has an idea that there is not a metal weight of 12 ounces to represent the Troy pound.

But there is no such thing. Twelve Troy ounces make a pound, but there is no such material unit of measurement. There are the grain, the scruple, the drachm, and the ounce weights, but nothing more. The man who has ten pounds of gold in reality has only 120 ounces, and for him to go into the gold market and speak of gold as the pound would be for him to be laughed at.

Incidentally these units of measurement in the Troy scale look a good deal more like Greek or Chinese coins than they look like weights, says the Chicago Tribune. For the average high school graduate to pick up a set of these weights would be to bewilder him.

It is the contemplation of such absurdities of the English tables of weights and measurements that bring the student to the metric system as the sane solution of it all.

WOMEN VOTERS.

Are More Conscientious Regarding Their Franchise Privileges Than Men.

An Australian newspaper tells of some curious facts shown by the new electoral rolls of South Australia. The number of men on the rolls has shrunk in a little over three years from 83,640 to 76,707. On the other hand the women voters have increased during the same period from 68,375 to 71,682. In the three chief metropolitan districts the men voters have dropped from 36,587 to 30,484, a reduction of nearly 16 per cent. Women voters in the same district have slightly increased their numbers, and now count no less than 32,501. The women seem to be growing more conscientious in the fulfillment of their political duties and the men more careless.

When equal suffrage was granted in New Zealand the estimated number of adult women in the country was 139,915. Of these, 109,461 registered to vote. Of the women who registered, 83 per cent. voted; of the men who registered, only 67 per cent.

According to the report of the Wyoming secretary of state, 90 per cent. of the women vote. In Denver, at the election last November, 31,780 men voted and 23,449 women.

HUMAN BEINGS NOT IMMUNE

Records Show That Contagious Diseases Frequently Attack People a Second Time.

It is a fallacy, widespread but nevertheless a fallacy, for anyone to suppose that a person who has once had smallpox, measles, scarlet fever or other contagious disease is thereby made immune to that particular disease for the rest of his life. A Swiss physician has been examining the records of such diseases, and in the statistics at his disposal—which are very defective, as comparatively few physicians take the trouble to report such observations to the medical journals—he finds no less than 528 persons who have had smallpox twice, nine who have had it three times and one who has had it seven times. For scarlet fever he finds 144 double and seven triple attacks. A hundred and three persons had two and three had seven attacks of measles; 203 had typhus twice, five thrice, one four times, and even cholera shows 29 second and three third attacks. The natural inference is that during the prevalence of an epidemic one should not rashly expose himself to contagion even if he has already had the disease.

MAKE BEGGING A BUSINESS.

Two Young Men Who Raise Money for Charitable Institutions for a Percentage.

Two of the most energetic and successful young men of Philadelphia follow the odd business of petitioning money for charities, says the Record of that city.

You, for instance, are interested in an orphan asylum that has a deficit this year of \$8,000. You go to the young men and tell them you want the money.

"Leave us," they make answer, "all your literature—your catalogues, reports, announcements—everything you have ever published."

And they master that literature and then they visit the asylum and inspect it thoroughly. By this time they acquaint themselves with the character of the institution in question, learning whether or not the benevolent rich would be likely to help it if its case were laid before them. According to that likelihood they set their price, saying they will "beg" for the place if they are given ten, twenty, or thirty per cent. of all the money they solicit.

They make, it is estimated, \$3,500 a year a piece.
